Site Visit Information:

1. The ESRC will visit two windfarm sites. The first site visit will be to the Pakini Nui wind farm in the morning, followed by the Lalamilo windfarm site mid-afternoon. Please use the contact information provided at the end of this agenda for any questions.
2. It is recommended that members of the public bring water and lunch, sunblock, hat, and hiking boots or comfortable sneakers.
3. Estimated Schedule:
  - For Pakini Nui – Public participants can rendezvous with the group at either:
    - A) BY 9:00 AM at the parking lot of the Hawai'i Gateway Energy Center, Natural Energy Laboratory of Hawai'i, 73-4485 Kahilihili Street, Kailua-Kona (just off Queen Ka'ahumanu Highway), or
    - B) At 11:00 AM at the gated entrance to Pakini Nui at 93-1373 South Point Rd (at orange barricades) (group arrival from Kona may be slightly later).
  - For Lalamilo –Meet at the Hapuna Beach State Recreation Area Parking lot at 3:00 PM (group arrival from Kona may be slightly later). The group will then transit to the site.
  - The site visit at Lalamilo is expected to end by 4:30 PM.
