### ENDANGERED SPECIES RECOVERY COMMITTEE MEETING (SITE VISIT)

Place: 1) Makamaka'ole Seabird Mitigation Site, meet at Division of Forestry and Wildlife Baseyard by 9:15, located at the corner of Kuleana and Haleakala Highway in Kahului, Maui.  
2) Kaheawa Wind Farm II, 3000 Honoapiilani Highway, Wailuku

#### Site Visit Information:

1. The Endangered Species Recovery Committee will meet for a site visit regarding the Habitat Conservation Plan and draft Amendment to that plan submitted by Kaheawa Wind Farm II. The draft HCP can be viewed here: <https://dlnr.hawaii.gov/wildlife/files/2013/09/KWP2-Draft-HCP-amendment-DOFAW-9-27-17.pdf>. The ESRC will visit two sites. The first will be to the seabird mitigation site Makamaka'ole, in the morning, followed by the Kaheawa Wind Farm II site in the afternoon.
2. The site visit will require 4WD vehicles. Members of the public interested in participating should contact the DOFAW representative listed below for vehicle arrangements. It is suggested to bring water and lunch (no food/water will be available for purchase), sunblock, hat, and hiking boots or sneakers with good traction. We will meet at the Division of Forestry and Wildlife Baseyard located at the corner of Kuleana and Haleakala Highway in Kahului, no later than 9:15 AM on November 27, 2017.
