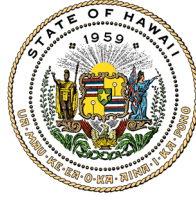

### **ITEM 3. VOTE ON WHETHER TO HOLD A LIMITED MEETING, AS DEFINED IN HRS § 92-3.1, AT WHICH PUBLIC ATTENDANCE IS NOT PRACTICABLE, TO CONDUCT AN ON-SITE INSPECTION OF PROPOSED MITIGATION SITES FOR KAUA'I ISLAND UTILITY COOPERATIVE'S (KIUC) DRAFT HABITAT CONSERVATION PLAN (HCP)**

Jesse Adams presented, on behalf of the Division of Forestry and Wildlife HCP Section, background on the KIUC Second Draft Habitat Conservation Plan.

### **Questions and Comments from the ESRC Members**

Kawika asked clarifying questions about projected numbers of streetlights and miles of transmission lines and if these have always been included in the HCP. Michelle explained that these numbers are estimates of new infrastructure that is reasonable to project over the requested ITP/ITL term, and that these estimates have always been included in the HCP.

Melissa asked for more information about the logistics for the site visit, and what purpose it serves. Karen wanted to know what the goals of the site visit are. Kawika and Karen commented that they will not go on a trip if helicopter operations are involved. It was then determined that Honopū would be the best site to visit. Dawn spoke to the benefits of visiting the Honopū site where conservation actions like predator control and colony monitoring are taking place. She reminded the Committee that contractors would be available to answer questions.

Melissa asked how the site visit will move the HCP forward. Michelle asked about the requirements for a site visit under HRS § 195D. Jesse then read HRS §195D 25(b)-1 which requires the Committee to make a site visit. Danica asked when the HCP had been last reviewed. ESRC review of the first draft took place in 2023 and a site visit was conducted on

February 29<sup>th</sup>, 2023. This involved an in-person visit to powerlines to look at minimization measures. Melissa noted it has been two years since the Committee last saw a draft.

Kawika reminded the Committee that the applicant had sent updated drafts incorporating their concerns after the Committee's review in 2023. However, Danica reminded everyone that the Committee has never officially reviewed this second draft because it has never been an agenda item. Melissa expressed concern about conducting the site visit before the second draft HCP has been officially reviewed. Jesse provided an updated timeline of the next steps in this HCP approval process. Kawika and Karen shared that they would like to review the HCP before the site visit.

Michelle asked how long the public comment period is. Jesse stated that it was 60 days. He then asked if the ESRC wanted public comments before they reviewed the HCP. Kawika and Melissa commented that they did. Danica asked when the second draft is formally reviewed that all committee members go on record and state if they: **1)** individually met with KIUC, **2)** what was said during those meetings, **3)** and what comments were provided.

Melissa asked if there were any important aspects of this project that have taken place in the past two years. Kawika stated that in the last draft Site 10 was identified but not promised. Danica reminded everyone of the agenda item and that conversation needs to be limited to this topic. Melissa rephrased her question to reflect this and asked why the Committee has not seen the new draft in the past two years. Michelle commented that there has been significant revision of the HCP document done by KIUC.
