

LETTER OF EXEMPTION MAIL REQUEST



Section 183D-28 (Hunter Education Program), Hawai'i Revised Statutes, requires that all State of Hawai'i hunting license applicants exempted from the requirement of successfully completing the Hawai'i Hunter Education Program course must apply for a "Letter of Exemption" issued by the Department of Land and Natural Resources.

To apply for a "Letter of Exemption" you must meet one of the following conditions:

You were born before January 1, 1972 and can show proof that you possessed a State of Hawai'i hunting license before July 1, 1990.

OR

You must show satisfactory proof that you successfully completed a Basic Hunter Education or safety course from another state/province or any Hunter Education or safety program approved by the International Hunter Education Association and the U.S. Fish and Wildlife Service. (**Bow hunter cards are not accepted as the State of Hawai'i has only a general hunting license.**)

If you fulfill the above conditions, complete and check off (✓) the following four steps:

1. Sign and date this application form.
2. Include a clear photocopy of valid identification (i.e. Military I.D. (**front/back**), driver's license, etc.)
*Proof of Hawai'i residency would include, but is not limited to a Hawai'i Drivers License, State of Hawai'i I.D., or copy of a Hawai'i voter registration stub.)
3. Include a legible photocopy of a State of Hawai'i Hunting License issued prior to July 1, 1990 or a Hunter Education or Safety Certificate (**front/back**) showing that you have successfully completed a course from another state/province.
