REMARKS:

The DOT has no objections to KSH's request and therefore, in accordance with Sections 171-11 and 171-55, HRS, relating to Public Purposes and Permits, respectively, and therefore, the DOT proposes to issue a month-to-month parking permit to KSH for aircraft parking at KOA.

RECOMMENDATION:






