Issuance of a Revocable Permit for Aircraft Parking (Parking Permit) to
Steven E. Prindle, situated at Kalaeloa Airport.

LOCATION AND TAX MAP KEY:

AREA:

Area/Space No. 405-124, containing an area of approximately 849 square feet,
as shown and delineated on the attached map labeled Exhibit "A".

Land presently encumbered by Governor's Executive Order No. 3861, setting aside Kalaeloa Airport under the control and management of the Department of Transportation, Airports Division, State of Hawai'i, for Airport Purposes.

CHARACTER OF USE:

Aircraft Tie-down (2010 Pitts S-1C, Tail No. N-691CP)

COMMENCEMENT DATE:

To be determined by the Director of Transportation at a later date.

MONTHLY RENTAL:

\$24.00 (as determined from the DOTA schedule of rates and charges established by appraisal of Airports property statewide)

SECURITY DEPOSIT:

Three (3) times the monthly rental in effect.

REMARKS:

The issuance of a Parking Permit to Steven E. Prindle, at Kalaeloa Airport complies with Chapter 343, Exemption Class 1.D.10 as a continuing aeronautical use, and is in accordance with Section 171-55 HRS, relating to Permits.

RECOMMENDATION:

That the Board authorize the Department of Transportation to issue a month-to-month Parking Permit to Steven E. Prindle, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.

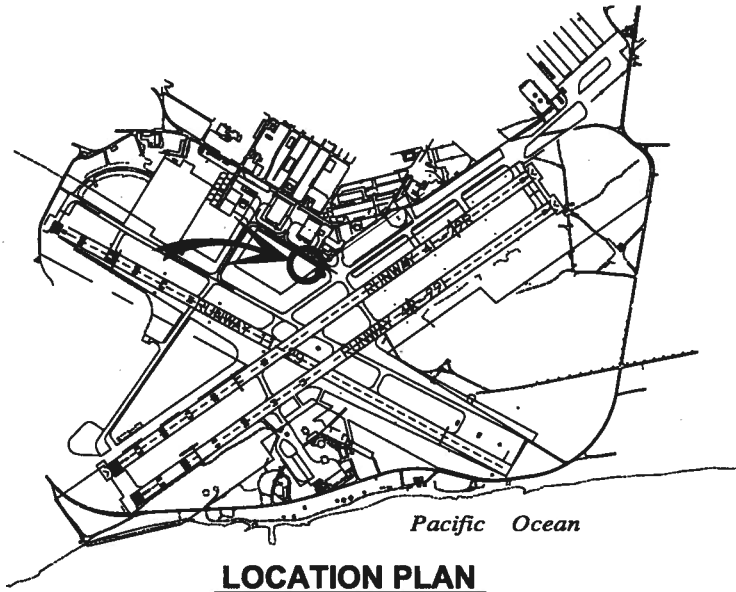

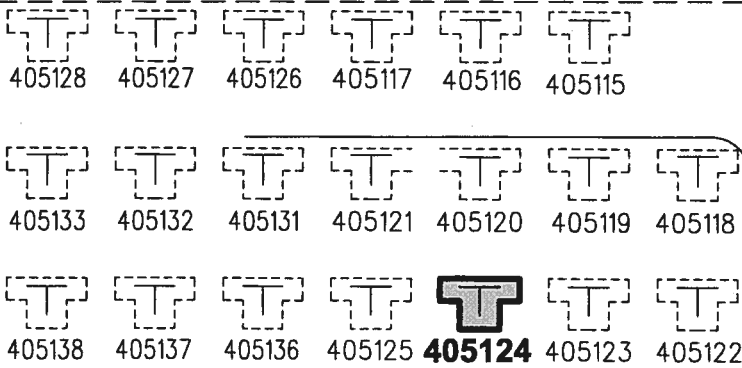
