Approval for Award of Construction Contract and Declare Project Exempt From Preparation of Environmental Assessment Requirements of Chapter 343, HRS, and Title 11, Chapter 200, Hawaii Administrative Rules

for

Job No. 500BK54J, Stream Mouth Maintenance at Various Locations, Kauai, Hawaii

This project consists of leasing equipment with an operator for clearing and cleaning the stream mouths at Waimea River, Wailua River, and Kapa'a River on the island of Kaua'i.

Bids were opened on April 7, 2016. Cushnie Construction Company, Inc. was the low bidder in the amount of \$171,600. In addition, pursuant to Chapter 343, Hawaii Revised Statutes (HRS), and Chapter 11-200, Hawaii Administrative Rules (HAR), the attached Exemption Notification labeled Exhibit A was prepared.

In accordance with HAR Section 11-200-8(a), and the Exemption List for the Department of Land and Natural Resources, which was reviewed and concurred by the Environmental Council on June 5, 2015, the subject project is exempt from the preparation of an environmental assessment pursuant to Exemption Class No. 1, that states, "Operations, repairs, or maintenance of existing structures, facilities, equipment, or topographical features, involving negligible or no expansion or change of use beyond that previously existing."; and Exemption Item No. 39 of Class No. 1 further states: "Removal of silt, debris, sand, and limu from above high water mark, from river and stream mouths, and from boat launching ramps."

Funding for this project is available from the Land Division's Land Maintenance Special Fund.

RECOMMENDATION

1. That the Board approve the award of DLNR Job No. 500BK54J, Stream Mouth Maintenance at Various Locations, Kaua'i, Hawai'i and delegate authority to the Chairperson to enter into a contract to implement the project.
2. That the Board delegate authority to the Chairperson to enter into supplemental contracts to address unforeseen project-related conditions and sign the necessary documents to implement the additional work with the Contractor.

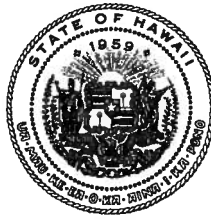
