CURRENT USE STATUS:

Encumbered under Governor's Executive Order No. 4203 dated October 23, 2007 to the Division of Forestry and Wildlife for Puuwaawaa Forest Reserve.

CHARACTER OF USE:

Right, privilege and authority to construct, use, maintain and repair a perpetual, non-exclusive easement for drainage improvements.

CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

See Exemption Notification (Exhibit B)

DOT-Highway's Declaration of Exemption, Class 2, B2, Facilities, states, "Upgrade or replace utility and drainage systems to maintain a consistent level of service. Drainage improvements will generally consist of installation of pipe culverts, construction of gutters where minor flooding occurs."

On May 13, 2105, a categorical exclusion was approved by the Federal Highways Administration under the National Environmental Policy Act.

DCCA VERIFICATION:

Not applicable. As a government agency, Applicant is not required to register with DCCA.

APPLICANT REQUIREMENTS:

Applicant shall be required:

1. Provide survey maps and descriptions according to State DAGS standards and at Applicant's own cost.

REMARKS:

By memorandum dated June 29, 2016, the Department of Transportation, Highways Division (DOT-Highways), requested a perpetual, non-exclusive easement and issuance of a construction right-of-entry at Puuwaawaa, North Kona, Hawaii. The purpose of the easement is to construct drainage improvements that will keep rainwater runoff from flowing across the roadway travel lanes and improve the overall safety for passing motorists on Mamalahoa Highway. Other improvements involve reconstructing the shoulder swales to accommodate the drainage improvements and constructing retaining walls adjacent to the reconstructed shoulder swales.

Portions of the drainage easement will be on State lands encumbered under Governor's Executive Order No. 4203 to the Division of Forestry and Wildlife (DOFAW) for the Puuwaawaa Forest Reserve. Mr. David G. Smith, DOFAW Administrator, was contacted and is in agreement with the granting of the easement and right-of-entry.

Construction is anticipated to commence in February 2017 and continue for ten (10) months.

DOT-Highways has not had a lease, permit, easement or other disposition of State lands terminated within the last five years due to non-compliance with such terms and conditions.

Various governmental agencies and interest groups were solicited for comments. Upon receipt of those responses, the comments will be included in the final submittal.

DOT-Highways has been working with DOFAW and State Historic Preservation Division in the planning of this project. DOT-Highways has a July 2016 deadline to request a federal construction funding appropriation. As a result, this request is a rush. Comments from other agencies are forthcoming, and will be forwarded to the board for review prior to the Land Board Meeting of July 22nd. Requests for comments have been sent to the Office of Hawaiian Affairs, County Planning Department, and Department of Public Works.

RECOMMENDATION: That the Board:

- 1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
- 2. Subject to the Applicant fulfilling all of the Applicant requirements listed above, authorize the issuance of a perpetual non-exclusive easement to the Department of Transportation, Highways Division covering the subject area for drainage improvement purposes under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
 - A. The standard terms and conditions of the most current perpetual easement document form, as may be amended from time to time;
 - Β. Review and approval by the Department of the Attorney General; and
 - C. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.
- 3. Authorize the issuance of an immediate management and construction right-ofentry to the Department of Transportation, Highways Division, its consultants, contractors and/or persons acting for or on its behalf, over portions of the Mamalahoa Highway, under the terms and conditions cited above, which are by this reference incorporated herein and subject further to the following:
 - A. The standard terms and conditions of the most current construction and management right-of-entry permit form, as may be amended from time to time;
 - B. This right-of-entry shall terminate upon issuance of the grant of easement document; and
 - Such other terms and conditions as may be prescribed by the Chairperson C. to best serve the interests of the State.




