In accordance with Hawaii Administrative Rule Section 11-200-8 and the Exemption List for the Department of Land and Natural Resources approved by the Environmental Council and dated June 5, 2015, the subject request is exempt from the preparation of an environmental assessment pursuant to Exemption Class No. 1, that states "Operations, repairs or maintenance of existing structures, facilities, equipment, or topographical features, involving negligible or no expansion or change of use beyond that previously existing" and Item No. 51, that states "Permits, licenses, registrations, and rights-of-entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing."

#### APPLICANT REQUIREMENTS:

Applicant shall be required to:

- 1) Obtain concurrence from the DLNR Division of Boating and Ocean Recreation for any portions of the event (commercial activity) that will be held within Ocean Waters of the State;
- 2) Submit consideration for use of Government lands along with required insurance and fully executed ROE document to be provided by the DLNR Maui District Land Office.

### **REMARKS**:

MC&A Inc. is requesting a right-of-entry permit to utilize a 5,000 square foot portion of shoreline fronting the Grand Wailea Beach Resort for a one day beach event.

There will be 22 teams that will construct 22 boats using 22 boat kits consisting of cardboard, duct tape and plastic sheeting. Boats will be constructed on Grand Wailea property at Molokini Gardens. These teams will be evenly divided by all participants (10-18 people per team). Select participants from each team will then take their boat down to the water to race. The rest of the team is involved by building, decorating, or cheering their teammates on. Those racing will enter the water through 10 lanes on the beach, created with flags. There will be 2 heats to accommodate all teams.

The applicant has not had a lease, permit, easement or other disposition of State lands terminated within the past five years due to non-compliance with such terms and conditions.

There are no other pertinent issues or concerns. Staff has no objections to this request.

#### RECOMMENDATION: That the Board:

- 1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
- 2. Authorize the issuance of a right-of-entry permit to MC&A Inc. for a One-day boat building and race event covering the subject area under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
  - a. The standard terms and conditions of the most current right-of-entry permit form, as may be amended from time to time;
  - b. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.
