# **REMARKS**:

According to CH2M Hill, Inc., the City and County of Honolulu, Department of Design and Construction has contracted together with it to consider the installation of a secondary force main that connects the Kamehameha Highway Wastewater Pump Station located at the corner of Keehi Lagoon Park, to the Kapalama Interceptor Relief Sewer, Section IV, at the Sand Island Industrial Area.

A written request has been received from the applicant for a right-of-entry permit to access State lands. Temporary access over the State lands will include the Keehi Lagoon Beach Park. The work to be performed will include: biological, archaeological, cultural and topographic surveys, underground utility investigations and geotechnical borings. All of the survey work to be performed is intended to be non-invasive and will typically be a study of surface findings. Underground utilities will be located and marked for future reference. A truck-mounted rotary wash drill will be used to bore five (5) geotechnical boring holes. Tremie grout will be used to backfill the drilled holes. See **Exhibit 4** for the locations of the boring holes.

All of the work is estimated to be completed within a month and will be conducted during the daylight hours on a week day.

Department of Emergency Management, Department of Parks and Recreation, Division of State Parks of this Department have no objection to the request. Staff did not solicit comments from other agencies as the request pertains to the lands under the jurisdiction of these agencies only.

Applicant will approach the permittees as noted above regarding the subject request regarding their concurrences and will provide their concurrences to the staff when available. There are no other pertinent issues or concerns that staff is aware of.

# **RECOMMENDATION:** That the Board:

1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.




