Exemption Class #1 covers operations, repairs, or maintenance of existing structures, facilities, equipment, or topographical features involving negligible or no expansion or change of use beyond that previously existing.

REMARKS:

The Department of Transportation proposes to issue a permit to GSCI for the use of the space for a field office to perform support construction work, at no rent, as specifically stated under Contract No. 65175 State Project No. AO1092-20, NDWP Roadway Terminal Signage Improvements, Honolulu International Airport, Section 1.05, Provisions for Field Office/Storage Space: "Pending the availability of space on airport property, the State will issue a permit to the Contractor for the use of the space, at no charge, to be used specifically for a field office and/or storage of materials and equipment...."

RECOMMENDATION:

That the Board authorize the Department of Transportation to issue a month-to-month revocable permit to GSCI, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.

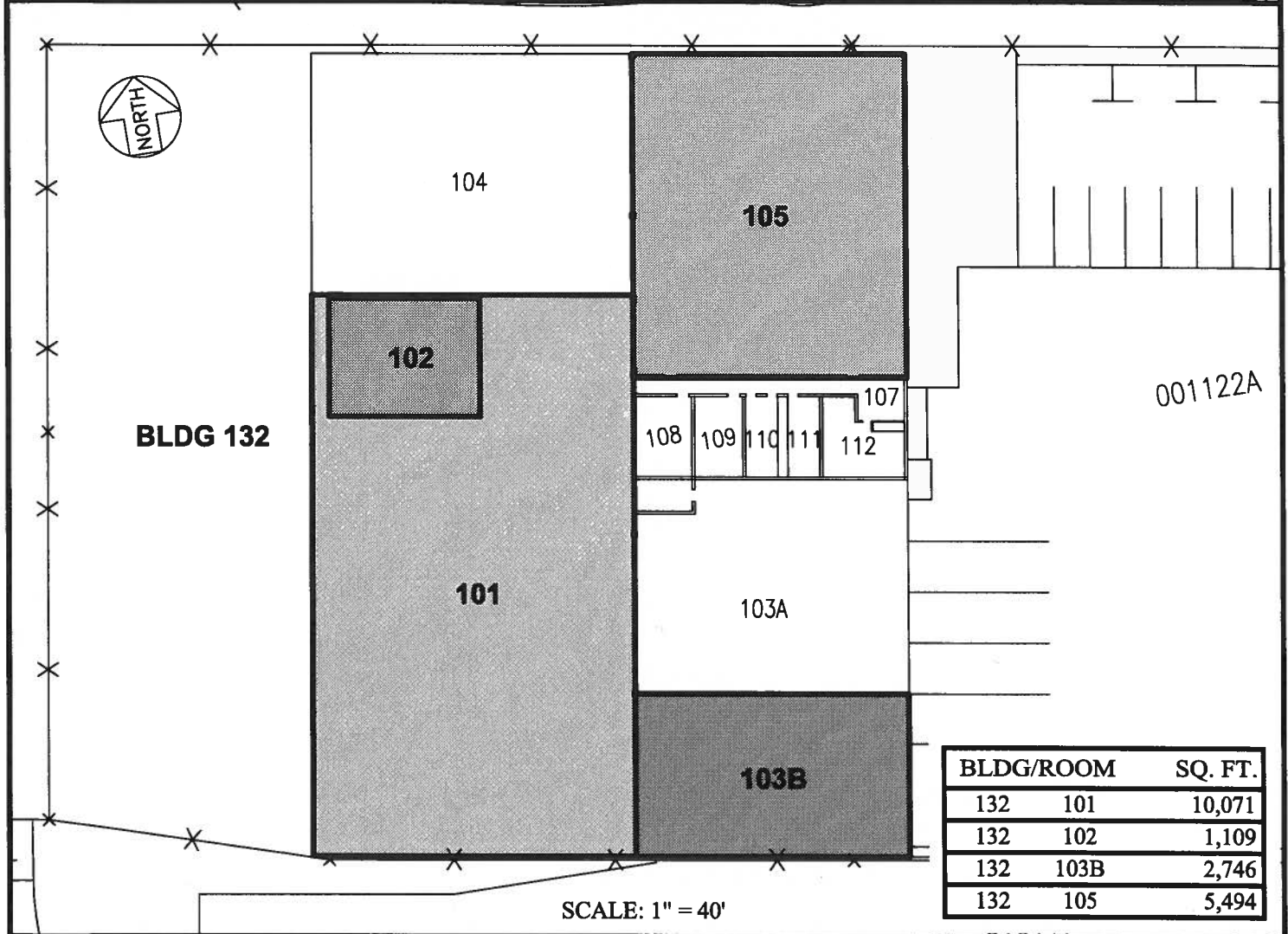
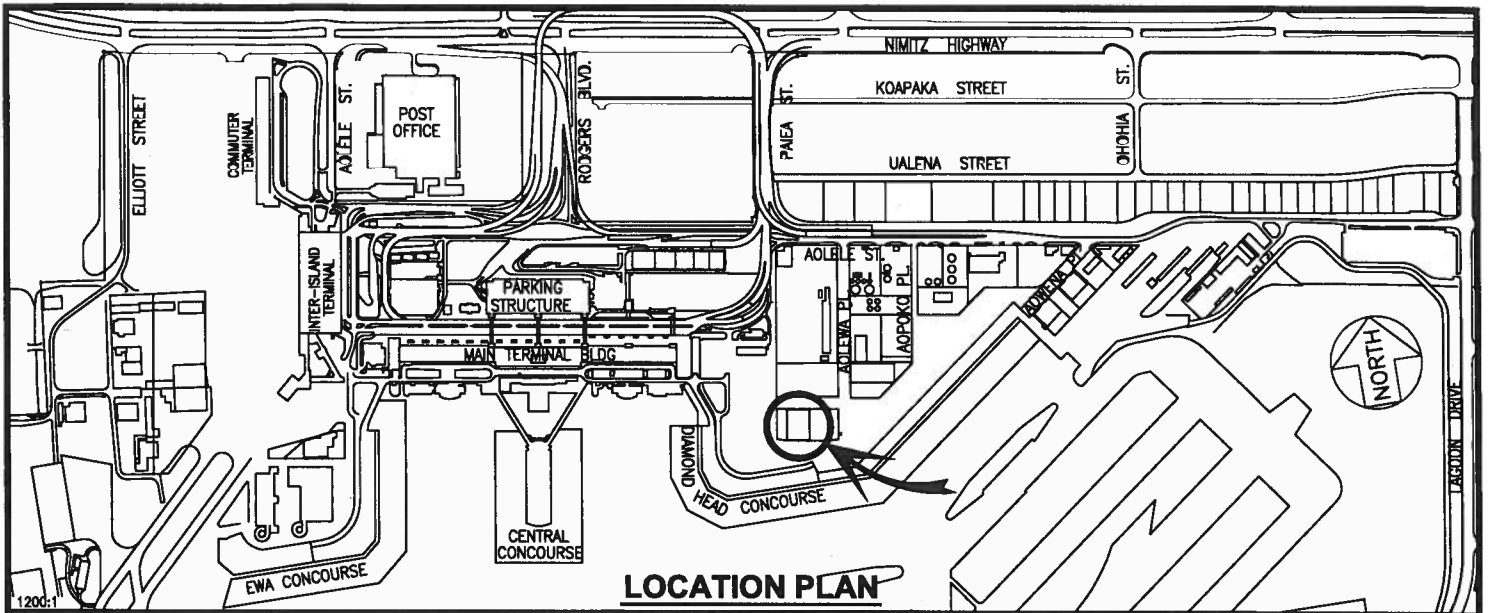
