The State of Hawai'i, Department of Transportation (DOT) is seeking the Board's consent to an amendment to a sublease between the DOT and DFS Group, L.P. for the In-Bond (Duty Free) Concession Agreement to add non-retail space to support Prada's boutique concession operation.

CONCESSION AGREEMENT TERM:

The In-Bond (Duty Free) Concession Agreement No. DOT-A-07-0001 (Lease)
commenced on June 1, 2007 and continues through May 31, 2027.

SUBLEASE AREA:

Area/Space No. 342-273M, containing an area of approximately 1,201 square feet of
retail floor area, as shown and delineated on the attached Exhibit A, Pages 1-3.

SUBLEASE TERM:

Term commences on approval and extends through the end of the Concession Term.

CHARACTER OF USE:

Non-retail uses, such are merchandise storage and other activities in support of the
concession sales.

CONCESSION FEE:

The In-Bond (Duty Free) Concession pays a Minimum Annual Guaranteed Fee (MAG)
plus an applicable percentage fee based on a schedule.

CHAPTER 343, HRS – ENVIRONMENTAL ASSESSMENT:

Pursuant to Section 11-200-8 (a), Environmental Impact Statement Rules of the Department of Health, State of Hawai‘i, this disposition is exempt from requirements regarding preparation of an environmental assessment, negative declaration, or environmental impact statement as required by Chapter 343, Hawai‘i Revised Statutes, as amended, relating to Environmental Impact Statements because the proposed action falls within Exemption Class #1, Comprehensive Exemption List for the State of Hawai‘i, Department of Transportation Amended November 15, 2000, as approved by the Environmental Quality Council. Exemption Class #1 covers operations, repairs, or maintenance of existing structures, facilities, equipment, or topographical features involving negligible or no expansion or change of use beyond that previously existing.

REMARKS:

The State of Hawai‘i, Department of Transportation, Airports Division has reviewed the Sublease and Sublease rent and determined that the Sublessee’s obligation are reasonable with no excess sandwich profit to be gained by the Lessee/Sublessor.

RECOMMENDATIONS:

That the Board approved and authorize the amendment to the Sublease between DFS Group, L.P., as Lessee/Sublessor and TRS Hawai‘i, as Sublessee, as hereinabove outlined, subject to: (1) terms and conditions as may be prescribed by the Director of Transportation to best service the interests of the State; (2) such terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State; and (3) review and approval of the Department of the Attorney General as to the Amendment form and content.

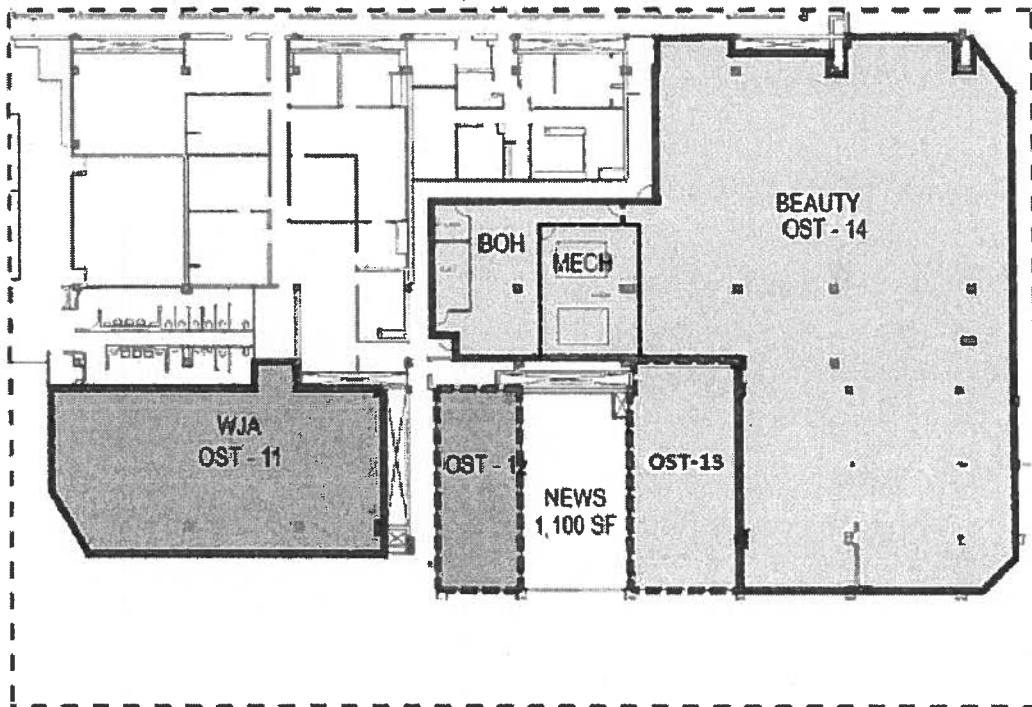
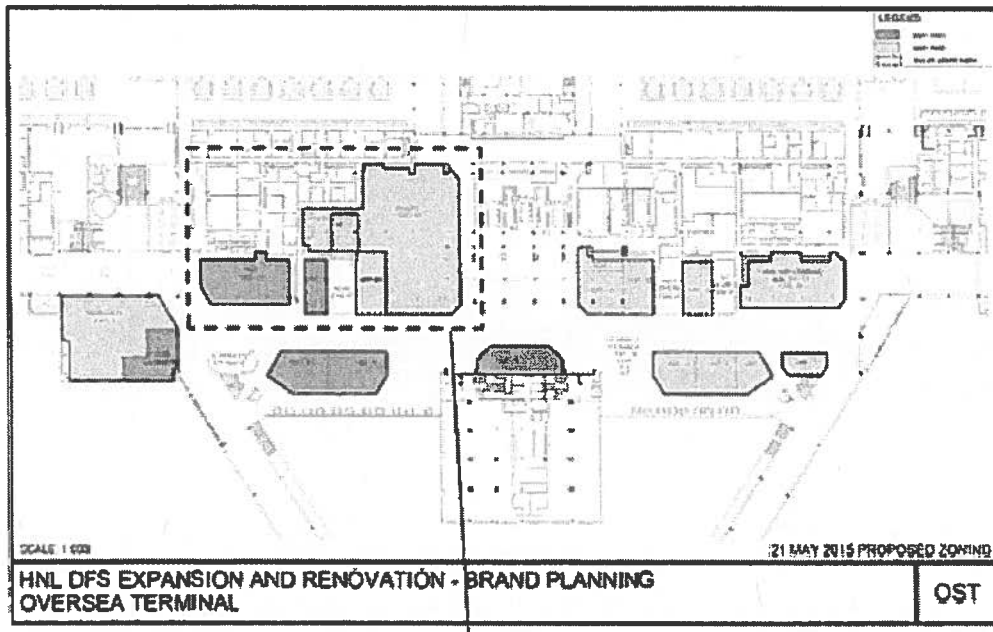

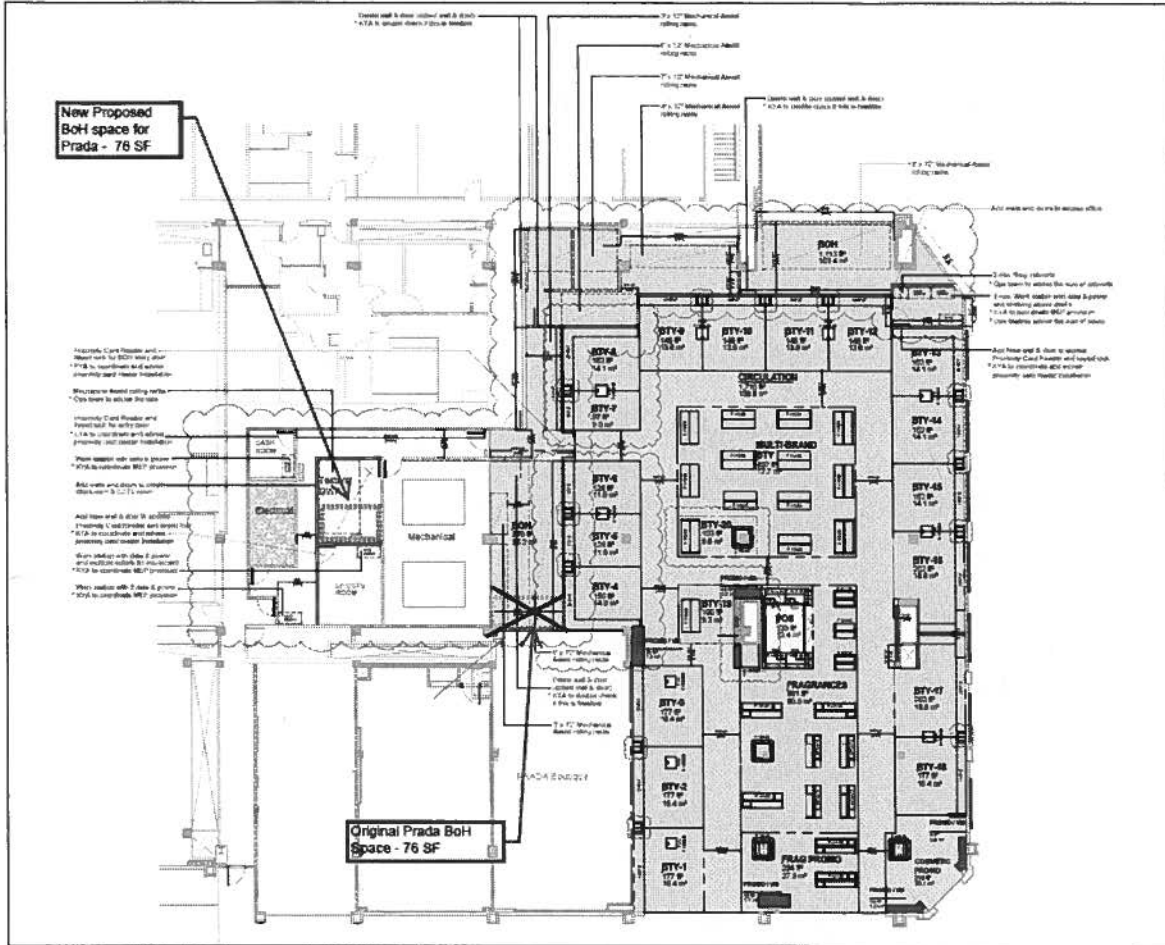

Location of Prada Boutique – Box OST-13





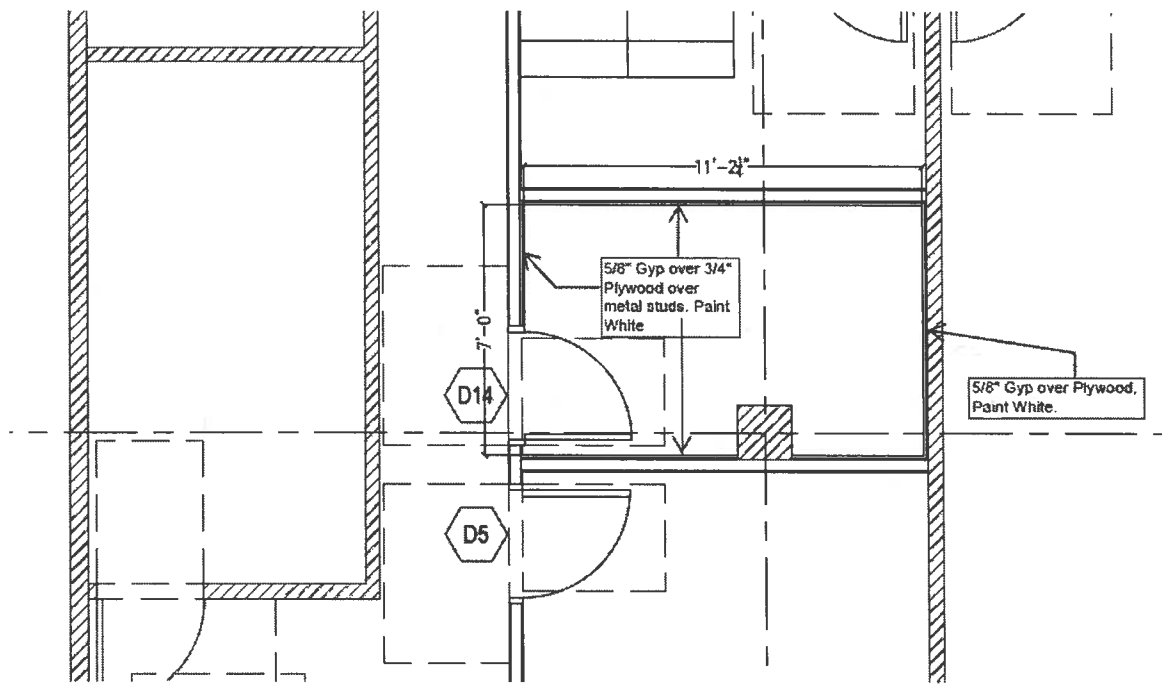
