### **PURPOSE:**

To amend the existing Restaurant and Lounge Concession Agreement DOT-A-92-0014 at Kahului Airport to add a new food and beverage space. Under Article III. (Premises) of the Lease, the specific areas assigned or provided for the concession activity may be changed at the discretion of the Director of Transportation.

No additional square footage floor rent will be charged. All gross receipts generated from the additional space will be included with the gross receipts of the concession. The concession pays the greater of minimum annual guaranteed rental or a percentage rental of gross receipts as provided in Article VI. (Rental).

# <u>CHAPTER 343, HRS – ENVIRONMENTAL ASSESSMENT:</u>
