within Exemption Class #1, Comprehensive Exemption List for the State of Hawai'i, Department of Transportation, dated November 15, 2000, as approved by the Environmental Quality Council. Exemption Class #1 covers operations, repairs, or maintenance of existing structures, facilities, equipment, or topographical features involving negligible or no expansion or change of use beyond that previously existing.

REMARKS

JAL will be resuming its non-stop daily flights between Tokyo and KOA after deleting the route in 2010 because of its financial struggles from a past bankruptcy. The flights will travel to and from Japan's Narita International Airport and KOA. Service to and from KOA will resume Sept. 15, 2017.

To accommodate its need for ramp offices, JAL will rent a two-story flex unit. The unit is mounted on a trailer base with an approximate floor area of 1,200 square feet.

The Department of Transportation (DOT) has no objections to JAL's request and therefore, in accordance with Sections 171-11 and 171-55, HRS, relating to <u>Public Purposes</u> and <u>Permits</u>, respectively and therefore, the DOT proposes to issue a month-to-month revocable permit to JAL for ramp spaces adjacent to the Main Terminal at KOA.

RECOMMENDATION:

That the Board authorize the Department of Transportation to issue a month-to-month revocable permit to JAL, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State
