Delegation of Authority to the Chairperson to: (1) Procure, Award and Enter Into Professional Service Consultant Contracts for Capital Improvement Program Projects as Listed in Exhibit 1 or Projects Funded with Operating Funds Appropriated by the Legislature; (2) Declare a Construction Project Exempt from the Preparation of an Environmental Assessment or Approve an Environmental Assessment and Issue a Finding of No Significant Impact, if Appropriate; and (3) Approve, Procure and Enter Construction Contracts for Capital Improvement Program Projects as Listed in Exhibit 1 or Projects Funded with Operating Funds Appropriated by the Legislature

The Engineering Division and other Departmental Divisions desire to implement and execute operating budget funded and/or Capital Improvements Program (CIP) funded projects by engaging consultants to provide various professional services and contractors to provide construction services for such projects. Operating budget funded projects authorized by the Legislature, include, but are not limited to, repair and maintenance, emergency response, hazard mitigation, or other types of work necessary for land management purposes. CIP funded projects are indicated and described, but not limited to, those listed in Exhibit 1. The list is arranged by Division and the Program ID in which the funds were appropriated.

DISCUSSION:

The General Appropriations Act of 2015 as amended by the Supplemental Appropriations Act of 2016, the General Appropriations Act of 2017, and other appropriations for which funds have not lapsed, authorize the expenditure of funds for the various projects.

All procurements will be made in accordance with the State Procurement Code, HRS Chapter 103D. Implementation of the various projects will comply with Budget Execution Policies issued by the Governor through the Department of Budget and Finance.

Professional service consultants will be procured in accordance with Hawaii Revised Statutes (HRS) Chapter 103D-304, and contracted to perform feasibility or planning studies, or other services. We request the Board to delegate authority to the Chairperson to approve, procure and enter contracts for such professional services.

All projects will comply with applicable provisions of HRS Chapter 343, and Title 11, Chapter 200, Hawaii Administrative Rules (HAR). We request the Board to delegate to the Chairperson the authority to declare a project exempt from the preparation of an environmental assessment (EA), or to approve an EA and issue a Finding of No Significant Impact (FONSI), for projects in which an

environmental assessment is prepared and result in such findings. All projects for which an environmental impact statement is prepared will be presented to the Board.


To move projects into the construction phase, we request that the Board delegate authority to the Chairperson to approve, procure and enter contracts for construction projects that do not require an EIS.

As in prior years, when asking for authorization for the Chairperson to enter contracts for professional services or construction, we have also requested the Board to authorize the Chairperson to sign supplemental agreements for those contracts, if necessary and appropriate. We therefore also request the Board to delegate authority to the Chairperson to sign such supplemental agreements, as needed.

RECOMMENDATION:

1. That the Board delegate authority to the Chairperson to procure, award and enter into professional service consultant contracts and, if necessary, supplemental agreements, in accordance with HRS Chapter 103D for various projects that are funded with operating budget or CIP funds as listed in Exhibit 1, and authorize the Chairperson to sign the necessary documents pertaining to the procurement and execution of the consultant contracts and implementation of the projects, subject to available funding, release of funds by the Governor, and review and approval as to form by the Department of the Attorney General.
2. That the Board delegate authority to the Chairperson to declare a construction project covered by this request exempt from the preparation of an EA or to approve an EA and issue a FONSI, if appropriate, and authorize the Chairperson to sign the necessary documents pertaining to the individual construction projects to make such declarations.
3. That the Board delegate authority to the Chairperson to approve, procure, award and enter construction contracts and, if necessary, supplemental agreements, in accordance with HRS Chapter 103D for various construction projects that are funded with operating budget or CIP funds as listed in Exhibit 1 and authorize the Chairperson to sign the necessary documents pertaining to the individual construction projects, subject to available funding, release of funds by the Governor, and review and approval as to form by the Department of the Attorney General.
