CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The DOTA consulted with the U.S. Federal Aviation Administration as to the appropriateness of the citation of the Environmental Exemption Class from the Comprehensive list for the Department of Transportation dated November 15, 2000. The FAA concurred on the appropriateness.

REMARKS:

The Department of Transportation proposes to issue a permit to Nan, Inc. for the use of the space for a field office to perform support construction work, at no rent, as specifically stated under Contract No. 65435, State Project No. AO1042-24, HNL Concession Improvements, Diamond Head Concourse, Daniel K. Inouye International Airport, Section 1.04 – Provisions for Field Office/Storage Space: “Pending the availability of space on airport property, the State will issue a permit to the Contractor for the use of the space, at no charge, to be used specifically for a field office and/or storage of materials and equipment....”

RECOMMENDATION:



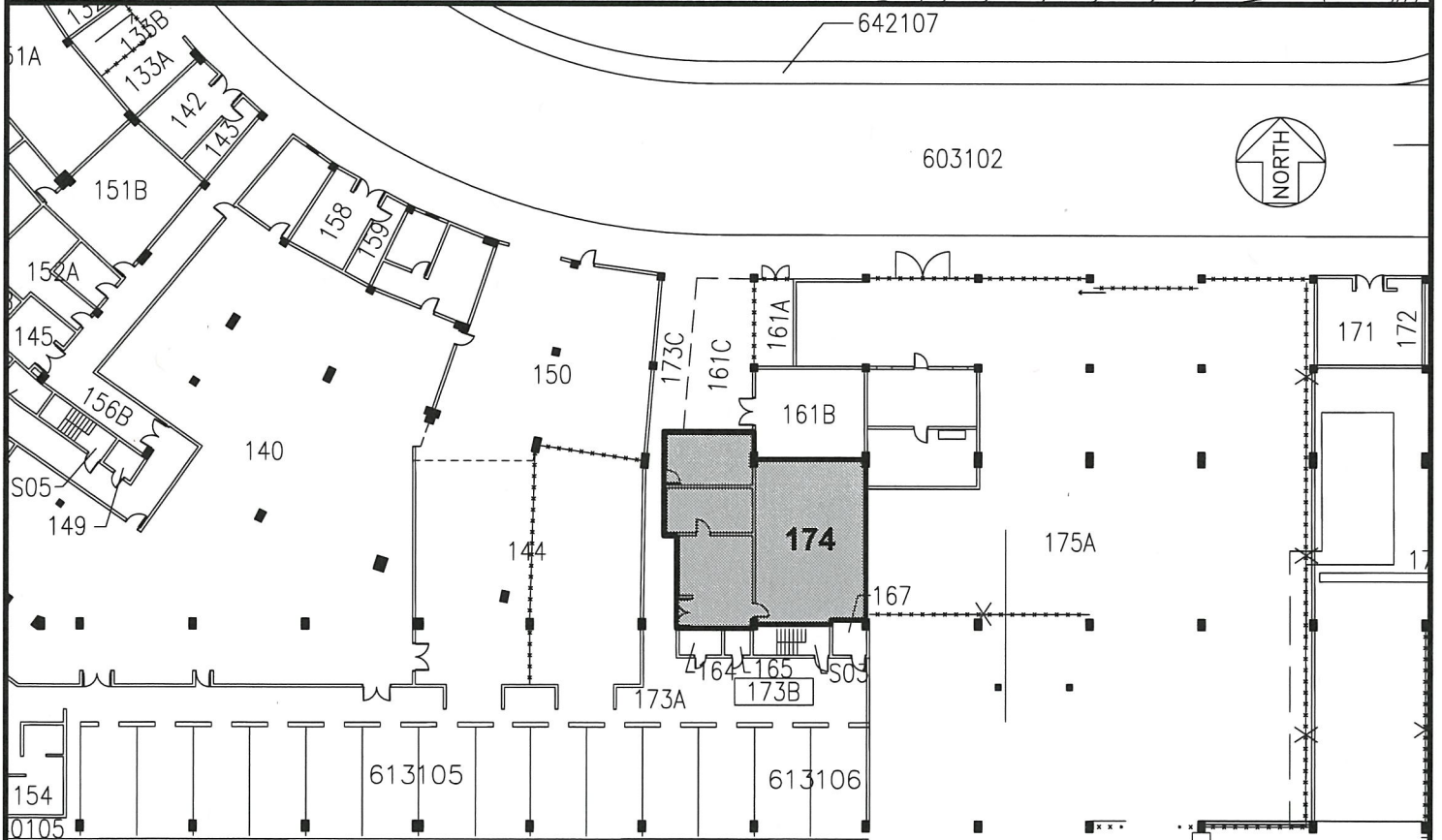
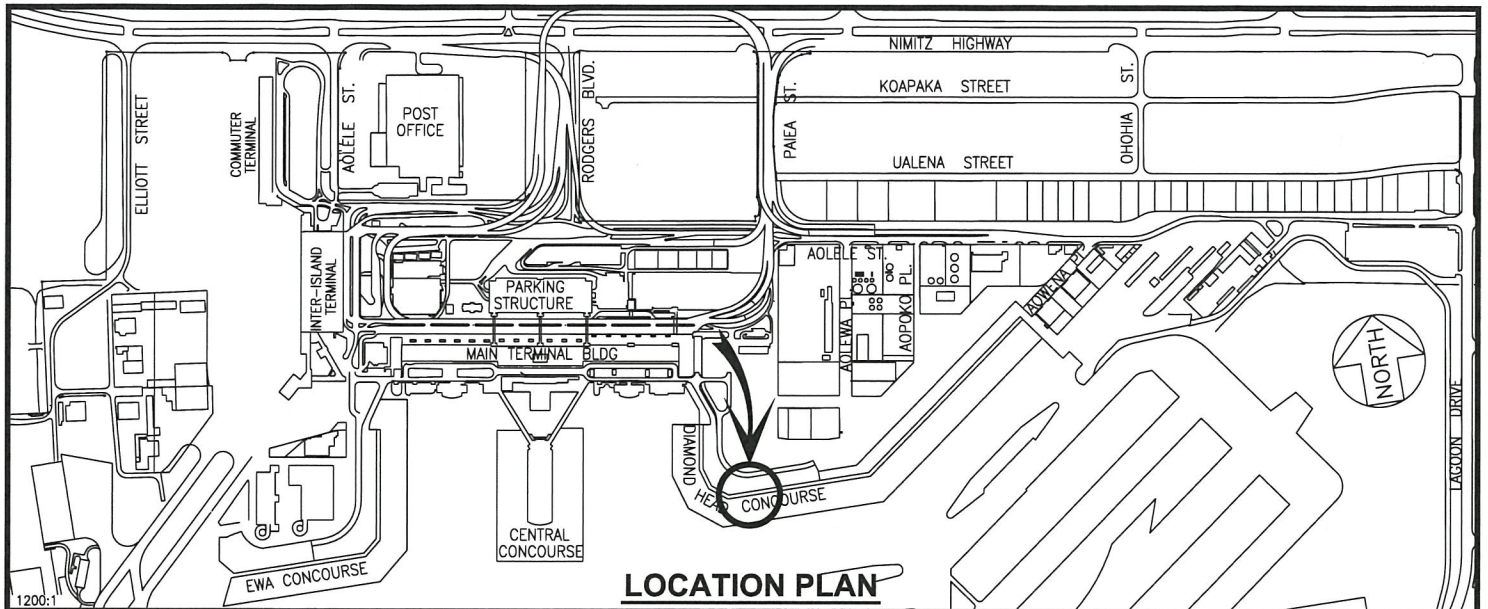
