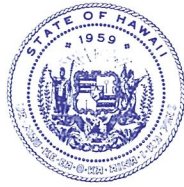

REQUEST:

Issuance of a revocable permit for aircraft parking (parking permit) to Sport Horse Sales of Texas, LLC.

The DOTA consulted with the U.S. Federal Aviation Administration as to the appropriateness of the citation of the Environmental Exemption Class from the Comprehensive list for the Department of Transportation dated November 15, 2000. The FAA has concurred on the appropriateness.

REMARKS:

The DOT has no objections to SHS's request and therefore, in accordance with Sections 171-11 and 171-55, HRS, relating to Public Purposes and Permits, respectively, and therefore, the DOT proposes to issue a month-to-month parking permit to SHS for its aircraft tie down at ITO.

RECOMMENDATION:



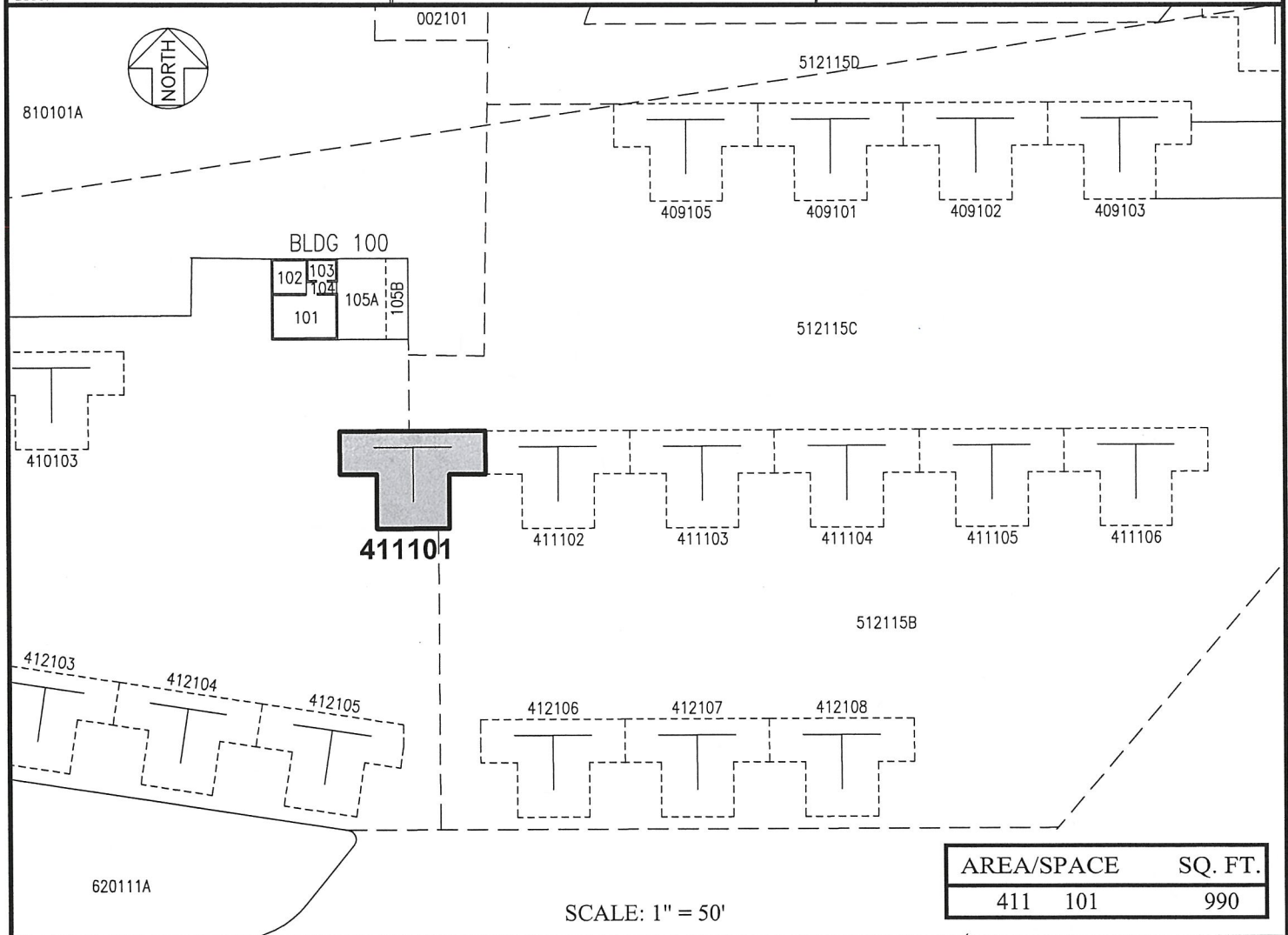
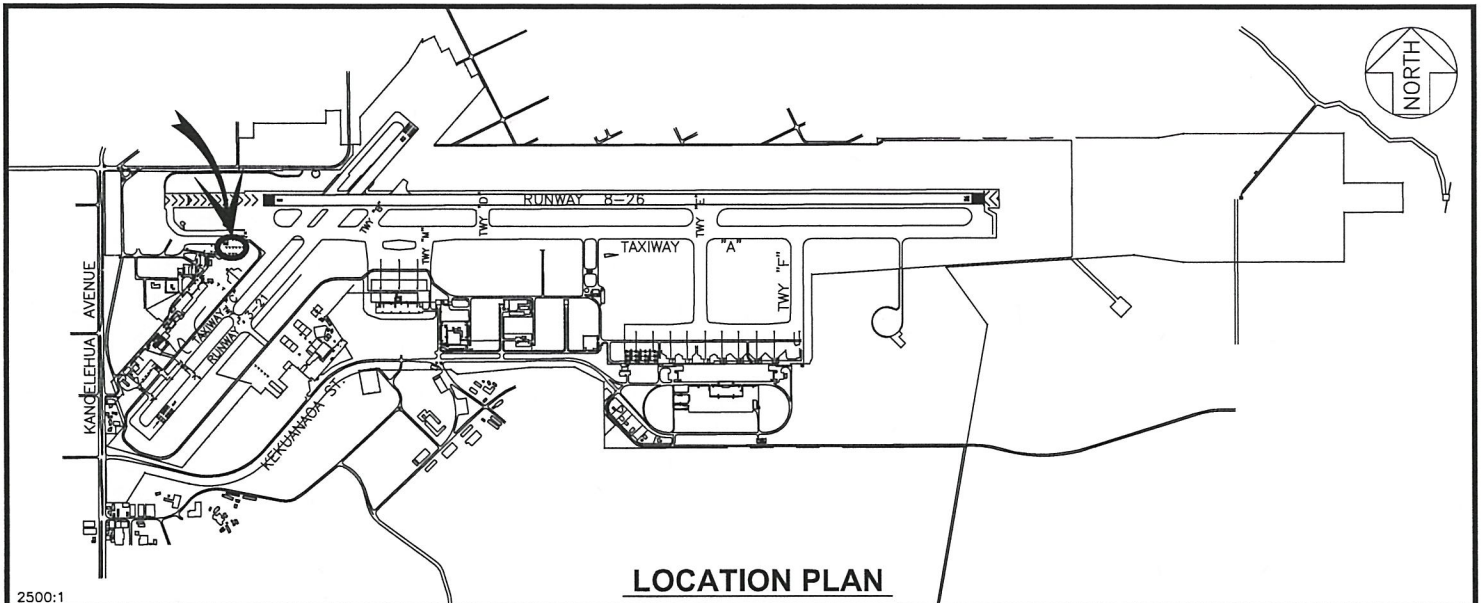
