These parcels are subject to Article XII, section 1 of the Constitution of the State of Hawaii, and 30% of receipts must be set aside to the Department of Hawaiian Home Lands (DHHL). A question recently arose as to whether that obligation to DHHL meant that the parcels are considered "available lands" which are excluded from the "public land trust" as defined by section 10-3, Hawaii Revised Statutes, and funds from these parcels were not set aside pursuant to Governor's Executive Order 06-06.
