CURRENT USE

STATUS:

Encumbered by Governor's Executive Order No. 3542, which sets aside

the land to the Harbors Division, Department of Transportation.

AREA:

Approximately 6,275 square feet

RENTAL:

\$4,769 per month or \$0.76 per square foot per month.

SECURITY

DEPOSIT:

\$9,538 or twice the monthly rental.

CHAPTER 343 ENVIRONMENTAL

ASSESSMENT:

An Environmental Assessment specifically for Piers 12 and 15 was published July 2013. "The Final Assessment (EA) meets the environmental guidelines and requirements of Chapter 343, HRS, as well as Act 241, Sessions Laws of Hawaii (SLH) 1992, and Chapter 200 of Title 11, Department of Health (DOH) Administrative rules, "Environmental Impact Statement Rules." (Page 10)

REMARKS:

Clean Island Council, Inc. has been a Harbors tenant in good standing since 1993.

Harbors Division developed and improved Pier 12 to provide new berthing and mooring structures and upgraded utilities to accommodate the Clean Island Council spill response barge. This was done to continue ongoing pollution prevention and response operations, in accordance with applicable Federal and State laws and regulations.

To provide continued environmental protection for Honolulu Harbor, Hawaii's primary port of entry for cargo and its economic lifeline to the rest of the world.

To locate spill responders in an area that allows quick access to all parts of Honolulu Harbor and dispatch to other incident locations throughout the State.

To consolidate the State's spill and emergency response assets to the extent possible, to maximize operational efficiency.

To support the State's overall, long-range plans for harbor development and utilization.
