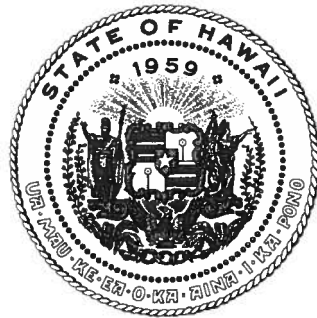

DISASTER RELIEF EXPENDITURES RESULTING FROM THE  
OCTOBER 15, 2006 KIHOLE BAY EARTHQUAKE

This report is prepared pursuant to Section 5 of Act 78, Session Laws of Hawaii 2007, which requires each department or agency expending funds authorized by this Act to submit annual reports to the Legislature, beginning no later than January 15, 2008. The information contained in the reports shall:

- (1) Be organized by county;
- (2) Provide summaries of expenditure data on a statewide basis; and
- (3) Include:
  - (A) The date of each expenditure;
  - (B) The purpose and description of each expenditure;
  - (C) The identification of any recipient of payments from each expenditure; and
  - (D) For funds not authorized by this Act but nevertheless used by any department or agency for the purposes of this Act:
    - (i) The source of those funds, by specific program;
    - (ii) The impact to the programs originally funded by those funds; and
    - (iii) The need for any emergency appropriations that resulted from the diversion of those funds.

This report covers expenditures of the Department of Land and Natural Resources up to October 31, 2011 and is submitted to satisfy the January 15, 2012 due date.
