REMARKS:

Hawaii Beach Volleyball Association (HBVA) is requesting a right-of-entry permit for a Dinosaur Beach Volleyball Tournament. The tournament is scheduled for March 16-18, 2018 from 8:00 am to 5:00 pm. Set-up will be at 7:00 am and break down will be completed by 7:00 pm.

HBVA states that no tents or spectator seating will be placed on the beach/State land by events coordinators. The tents and chairs will be placed on the Marriott Hotel grounds.

Applicant has not had a lease, permit, easement or other disposition of State lands terminated within the past five years due to non-compliance with such terms and conditions.

¹ Hawaii Beach Volleyball Association is an Internal Revenue Code Section 501(c)(3) qualified nonprofit entity. See Exhibit B. A \$120 entry fee collected from each team will be used to cover the expenses of the tournament. Hawaii Beach Volleyball Association will not realize any profit from the tournament. See Exhibit C for breakdown of the fees collected.

The proposed activity is of a similar type and scope of beach activities that routinely has occurred and continues to be held on this and other beaches across the State. Such activities have resulted in no known significant impacts, whether immediate or cumulative, to the natural, environment and/or cultural resources in the area. As such staff believes that the proposed event would involve negligible or no expansion or change in use of the subject area beyond that previously existing.



RECOMMENDATION: That the Board



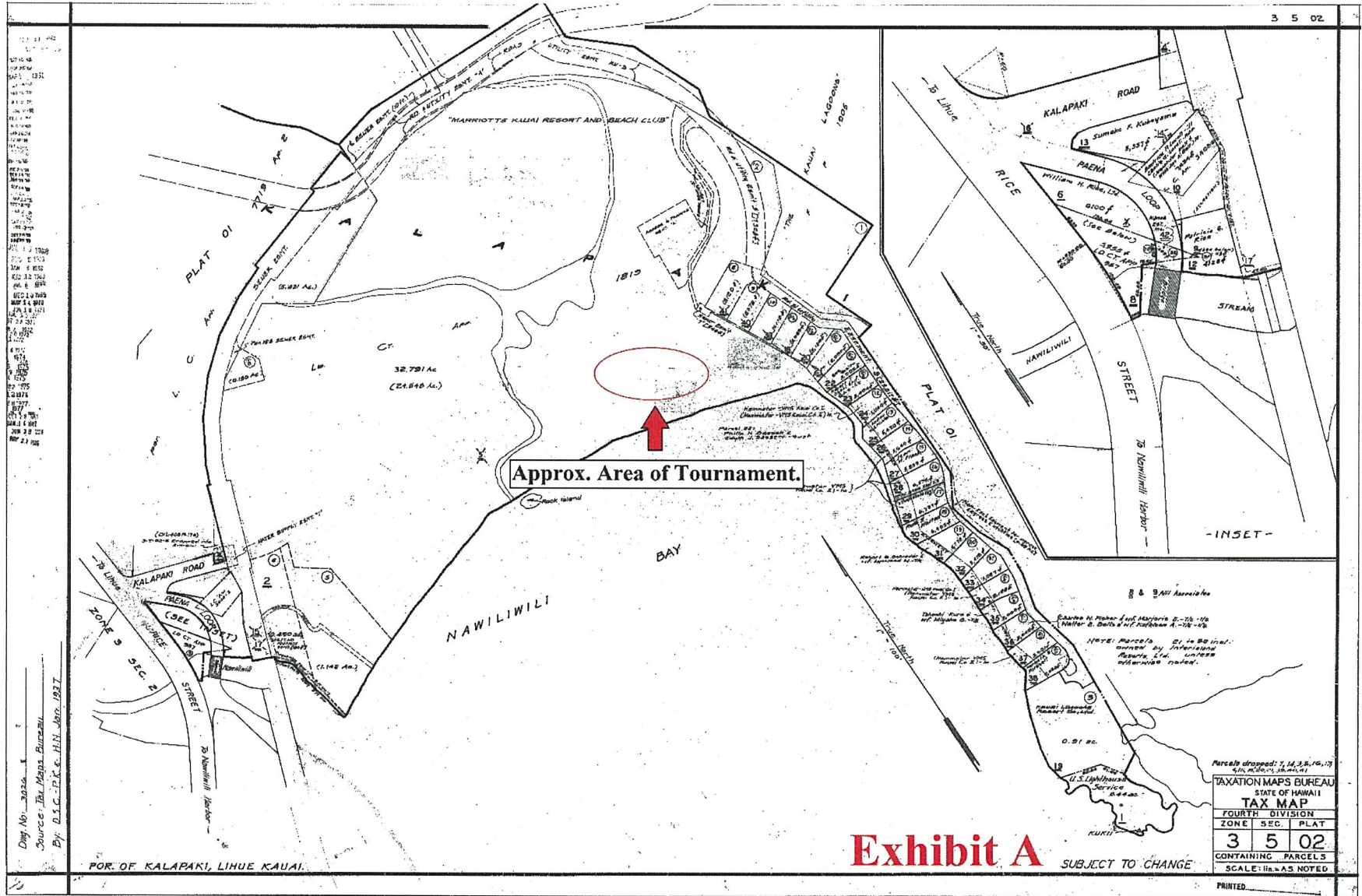

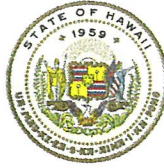
