AMENDMENT NO. 30 TO CONCESSION AGREEMENT NO. DOT-A-92-0018 FOR ADDITION OF STORAGE SPACE AND GREASE INTERCEPTOR RESTAURANT AND LOUNGE CONCESSION HOST INTERNATIONAL, INC. DANIEL K. INOUYE INTERNATIONAL AIRPORT TAX MAP KEY: (1) 1-1-003: 001 (PORTION)

#### **PURPOSE:**

To amend the existing Restaurant and Lounge Concession Lease No. DOT-A-92-0018 at Daniel K. Inouye International Airport for the addition of a food and beverage storage and grease interceptor. Under Article III. (Premises) of the Lease, the specific areas assigned or provided for the concession activity may be changed at the discretion of the Director of Transportation.

## **LAND TITLE STATUS:**

## TERM:

To run for the balance of the term of the existing concession agreement that expires on April 30, 2029.

## **ADDITIONAL PREMISES:**

Building 350-121A, containing an area of approximately 1,363 square feet for storage space, and 540-108, containing an area of approximately 120 square feet for grease interceptor, as delineated on the attached map labeled Exhibit B-55 and B-56 dated March 2018.

## <u>IMPROVEMENTS</u>:

Applicant at its own cost and expense shall be responsible for any renovation, upgrade, remodeling and improvements to the additional spaces.

#### **RENTAL**:

LESSEE shall pay for additional spaces requested and granted by the LESSOR, the annual sum of \$23,134.80 (Twenty-three thousand one hundred thirty-four and 80/100 Dollars) based on the applicable rate at \$15.60 per square feet per annum plus utilities.

within Exemption Class #1, Comprehensive Exemption List for the State of Hawai'i, Department of Transportation Amended November 15, 2000, as approved by the Environmental Quality Council. Exemption Class #1 covers operations, repairs, or maintenance of existing structures, facilities, equipment, or topographical features involving negligible or no expansion or change of use beyond that previously existing. The DOTA consulted with the U.S. Federal Aviation Administration as to the appropriateness of the citation of the Environmental Exemption Class from the Comprehensive list for the Department of Transportation dated November 15, 2000. The FAA concurred on the appropriateness.

## **REMARKS:**

The applicant identified and requested additional spaces and the Department of Transportation Airports Division reviewed and determined that the additional spaces for storage and grease interceptor are necessary for the proper and efficient operation of the Concession.

## **RECOMMENDATION:**

That the Board approve and authorize: (1) the Department of Transportation to amend Article III. (Premises) of the subject Lease as herein outlined, which are by reference incorporated herein; (2) such other terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State; and (3) review and approval by the Department of the Attorney General.
