# PURPOSE:

To amend the existing Concession Agreement No. DOT-A-17-0008 at the Daniel K. Inouye International Airport to add office and counter space. Under Article III (Concession Premises) of the Agreement, the specific area assigned or provided for the concession activity may be changed at the discretion of the Director of Transportation.

the proposed action falls within Exemption Class #1, Comprehensive Exemption List for the State of Hawai'i, Department of Transportation, dated November 2000, as approved by the Environmental Quality Council. Exemption Class #1 covers operations, repairs, or maintenance of existing structures, facilities, equipment, or topographical features involving negligible or no expansion or change of use beyond that previously existing.

The DOTA consulted with the U.S. Federal Aviation Administration as to the appropriateness of the citation of the Environmental Exemption Class from the Comprehensive list for the Department of Transportation dated November 15, 2000. The FAA concurred on the appropriateness.

#### **REMARKS:**

The Department of Transportation and Robert's Tours and Transportation, Inc. entered into that certain Concession Agreement No. DOT-A-17-0008, dated October 11, 2017, for the On-Demand Airport-Based Shuttle Bus Services Concession at Daniel K. Inouye International Airport. The additional office and counter space is integral to Robert's shuttle bus services operation at the Airport.

# **RECOMMENDATION:**

That the Board approve and authorize the addition of the office and counter space as hereinabove outlined, subject to: 1) terms and conditions herein outlined, which are by reference incorporated herein; 2) such other terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State; and 3) review and approval by the Department of the Attorney General.
