REMARKS:

The DOTA consulted with the U.S. Federal Aviation Administration as to the appropriateness of the citation of the Environmental Exemption Class from the Comprehensive list for the Department of Transportation dated November 14, 2000. In this case, the FAA concurred on the appropriateness.

That the Board authorize the Department of Transportation to issue a month-to-month Revocable Permit to William Wilton, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.
