Portion of Government lands of Kawaihae Harbor situated at Kawaihae, Hawaii, identified by Tax Map Keys: (3) 6-1-003: 025 (portion), (3) 6-1-003:026 (portion) and seaward of same, as shown on the attached map. See **Exhibit 1**.

AREA:

Areas withdrawn from the jurisdiction of Department of Transportation, Harbors Division ("DOT") by Governor's Executive Order ("GEO"), as follows:

CURRENT USE STATUS:

The Kawaihae SBH-South facility includes a loading ramp, floating dock with a 24-berth Tahitian mooring area, comfort station, and parking areas.

The subject property consists of 44.262 acres more or less of State lands, including submerged lands.

The subject property is encumbered by Revocable Permit No.29 issued to Island of Hawaii YMCA for sailing programs, storage purposes, marine education and youth programs, and RP No. 22 issued to Na Kalai Wa'a for vessel storage, general storage, maintenance of improvements, youth programs, educational programs, and affiliated community programs.

DOBOR also holds 24 commercial/recreational permits for the moorings/slips. See **Exhibit 2**.

PURPOSE OF SET ASIDE:

For Small Boat Harbor and related purposes.

CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

In accordance with Hawaii Administrative Rule Section 11-200-8 and the Exemption List for the Department of Land and Natural Resources, approved by the Environmental Council on June 5, 2015, the subject action is exempt from the preparation of an environmental assessment pursuant to Exemption Class 1, "Operations, repairs, or maintenance of existing structures, facilities, equipment, or topographical features,

involving negligible or no expansion or change beyond that previously existing;" Item 43, "Transfer of management authority over state-owned land, such as setting aside of state lands to or from other government agencies through a Governor's executive order." See **Exhibit 3** attached.

Inasmuch as the Chapter 343 environmental requirements apply to the Applicant's future use of the lands, the Applicant shall be responsible for compliance with Chapter 343, HRS, as amended.

BACKGROUND

The Kawaihae Harbor Project came into being with GEO No. 1759, which set aside 30.259 acres, more or less, of State lands on the northwest Kohala Coast to be under the control and management of the Department of the Army of the United States ("Army"). Development of the Harbor Project continued with portions of the Army lands being returned to the State of Hawaii by GEO 2142, as well as having been expanded several times throughout the years by numerous GEOs. This submittal concerns GEOs with land withdrawn from DOT's jurisdiction and intended to be set aside to DOBOR, pursuant to Act 272. The specific GEOs that are the subject of this submittal are discussed below.

One such expansion was accomplished by GEO No. 1904, dated March 17, 1960, which set aside 52.98 acres, more or less, for receiving or discharging passengers, and for loading and landing merchandise, with warehouse or warehouse space, office or office space, storage for wares and merchandise, and the like, to be under the control and management of the Board of Harbor Commissioners of the Territory of Hawaii, as part of the Kawaihae Harbor Project. At its meeting on December 12, 2014, under agenda item M-3, the Board of Land and Natural Resources ("BLNR") approved the withdrawal of 14.987 acres, more or less, from GEO No. 1904. The rationale for the withdrawal was to allow DOBOR to have its own road to the small boat harbor separate of DOT's security requirements. On December 19, 2016, by GEO 4524, 14.987 acres, more or less, were withdrawn from the DOT's jurisdiction.

The harbor was further expanded by GEO No. 1988 dated December 12, 1961, which set aside an additional 39.74 acres, more or less, for receiving or discharging passengers, and for loading and landing merchandise, with warehouse or warehouse space, office or office space, storage for wares and merchandise, and the like, to be under the control and management of the DOT. At its meeting on September 26, 2014, under agenda item M-4, the Board approved the withdrawal of 19.973 acres, more or less from GEO No. 1988. On November 23, 2016, by GEO No. 4521, 19.973 acres, more or less, were withdrawn from DOT's jurisdiction.

On June 2, 1964, by GEO No. 2142, 6.37 acres of filled land, previously returned by the United States of America, were set aside for addition to Kawaihae Harbor, to be under the control and management of the DOT, State of Hawaii. At its meeting on December 12, 2014, under agenda item M-3, the BLNR approved the withdrawal of 3.142 acres,

more or less, from GEO 2142. On December 19, 2016, by GEO 4523, 3.142 acres, more or less, were withdrawn from DOT's jurisdiction.

REMARKS

In 1991, Act 272 transferred the management authority of 54 small boat harbors, launching ramps, jetties, wharves and landings in the State from DOT to DOBOR. The Kawaihae SBH-South was one of the 54 SBHs to have been transferred.

Although in 1992 DOBOR took over management of Kawaihae SBH-South, then consisting of a designated mooring area within the larger commercial Kawaihae Harbor, the formal Executive Order to DOBOR still has not yet been completed. Notwithstanding the aforesaid, DOBOR has continued management and oversight over the small boat harbor area uninterrupted since 1992.

In 2008, DOBOR relocated the SBH-South outside of the deep-water commercial harbor and constructed a new facility comprised of a loading ramp, floating dock with a 24-berth Tahitian mooring area, comfort station, and parking areas.

In July of 2018, DOBOR notified Land Division staff ("Staff") of their desire to seek approval to enter into a direct lease with a 501(c)(3) entity at the Kawaihae SBH-South facility and requested that execution of this intended set-aside be prioritized to allow processing of the DBOR lease.

Staff consulted the agencies listed below on the submittal and proposed exemption from an environmental assessment with the results indicated:

The Board's approval of the following recommendations will bring the documentation status current for the Kawaihae SBH-South.

RECOMMENDATION:

That the Board:

- 1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS and Chapter 11-200, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from preparation of an environmental assessment.
- 2. Approve of and recommend to the Governor the issuance of an executive order setting aside a portion of the Kawaihae SBH-South lands described in GEO Nos. 4521, 4523, and 4524, together with 6.16 acres, more or less, of submerged land to the DLNR, DOBOR, under the terms and conditions cited above, which are by this reference incorporated herein and subject further to the following:
 - a. The standard terms and conditions of the most current executive order form, as may be amended from time to time;
 - b. Disapproval by the Legislature by two-thirds vote of either the House of Representatives or the Senate or by a majority vote by both in any regular or special session next following the date of the setting aside;
 - c. Review and approval by the Department of the Attorney General; and
 - d. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.
- 3. Grant an immediate management right-of-entry to the DLNR, DOBOR over the subject lands, under the terms and conditions cited above, which are by this reference incorporated herein and subject further to the following:
 - a. The standard terms and conditions of the most current management and construction right-of-entry form, as may be amended from time to time;

b. The right-of-entry shall be effective upon acceptance and shall terminate upon issuance of the executive order.

Department of Transportation to the Department of Land and Natural Resources, DOBOR through Act 272, SLH 1991 and have been managed accordingly since 1991.

There will be no changes in the use or management of this wharf beyond that currently existing. As such, staff believes that the completion of the set-aside as stipulated by Act 272 is exempt from the preparation of an environmental assessment.
