REMARKS:

On January 18, 2019, the Hawaii District Land Office received an application from Eleanor Soucy, Program Manager, HMS Global Solutions (an event planning company), on behalf of the Robertson Heating Supply. The application is for a right-of-entry permit to conduct a corporate retreat activity resembling a Beach Olympic Event upon unencumbered State lands at Kalapaki Beach. The Robertson Heating Supply Company is a corporate guest at the Kauai Marriott Resort Hotels Hawaii. The event will be for only two hours on February 28, 2019, between the hours of 10:00 am to 12:00 noon. Activities planned would include such games as coconut toss, water balloon toss, hula hoop relay and basketball pass & shoot. The dimensions of the beach area required will be about 20 square feet by 50 square feet, for a total of 1,000 square feet. There will be no vendors/concession tents upon the permit area.

On January 19, 2019, the Office of Conservation and Coastal Lands (OCCL) was contacted for comments to the request. Sam Lemmo, Administrator of OCCL responded having no objections.

Applicant has not had a lease, permit, easement or other disposition of State lands terminated within the past five years due to non-compliance with such terms and conditions.

Staff does not have any objections to the request.

RECOMMENDATION: That the Board

- A. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
- B. Authorize the issuance of a right-of-entry permit to Eleanor Soucy on behalf of the Robertson Heating Supply Company, covering the subject area under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
 - 1. The standard terms and conditions of the most current right-of-entry permit form, as may be amended from time to time;
 - 2. Permittee shall submit a check in the amount of \$100, made payable to the Department of Land and Natural Resources for this right-of-entry Permit;
 - 3. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.





Below is the proposed section of beach that we would like to use for the event:



Cumulative Impact of Planned Successive Actions in Same Place Significant: No. the request is a single occurrence in the area.

Action May Have Significant Impact on Particularly Sensitive Environment: No. the action proposed will have no significant impact to any particularly sensitive environment.

Analysis:

In the past, permits were issued for similar type of events on the beach in this area, which have resulted in no known significant impacts to the natural and environmental resources in the area. As such staff believes that the proposed event would involve negligible or no expansion or change in use of the subject area beyond that previously existing.

Consulted Parties:

County Planning and the Office of Conservation and Coastal Lands.

Recommendation:

It is anticipated this activity will probably have minimal or no significant effect on the environment as over the years, several other beach activities have been held at Kalapaki Beach. As a result, it will involve minimal or no significant effect on the environment and is presumed to be exempt from the preparation of an environmental assessment.
