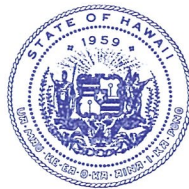

CURRENT USE STATUS:

Land presently encumbered by Governor's Executive Order No. 3201, dated June 8, 1983, setting aside 3,152.177 acres designated as Daniel K. Inouye International Airport under the control and management of the State of Hawai'i, Department of Transportation, Airports Division (DOTA) for Airport Purposes.

CHARACTER OF USE:

Air Service Hawaii, Inc. will use the space for temporary storage of ground service equipment at Daniel K. Inouye International Airport.

COMMENCEMENT DATE:

To be determined by the Director of Transportation at a later date.

MONTHLY RENTAL:

\$1,809.40 (\$1,754.40, as determined from the DOTA schedule of rates and charges established by appraisal of Airports property statewide plus \$55.00 for electricity).

SECURITY DEPOSIT:

Three (3) times the monthly rental in effect.

Exemption Class #1 covers operations, repairs, or

maintenance of existing structures, facilities, equipment, or topographical features involving negligible or no expansion or change of use beyond that previously existing.

The DOTA consulted with the U.S. Federal Aviation Administration as to the appropriateness of the citation of the Environmental Exemption Class from the Comprehensive list for the Department of Transportation dated November 15, 2000. The FAA concurred on the appropriateness.


REMARKS:

In accordance with Section 171-55, HRS, relating to Permits, the Department of Transportation proposes to issue a month-to-month revocable permit to Air Service Hawaii, Inc. for temporary storage of ground service equipment at Daniel K. Inouye International Airport.

That the Board authorize the Department of Transportation to issue a month-to-month revocable permit to Air Service Hawaii, Inc., subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.

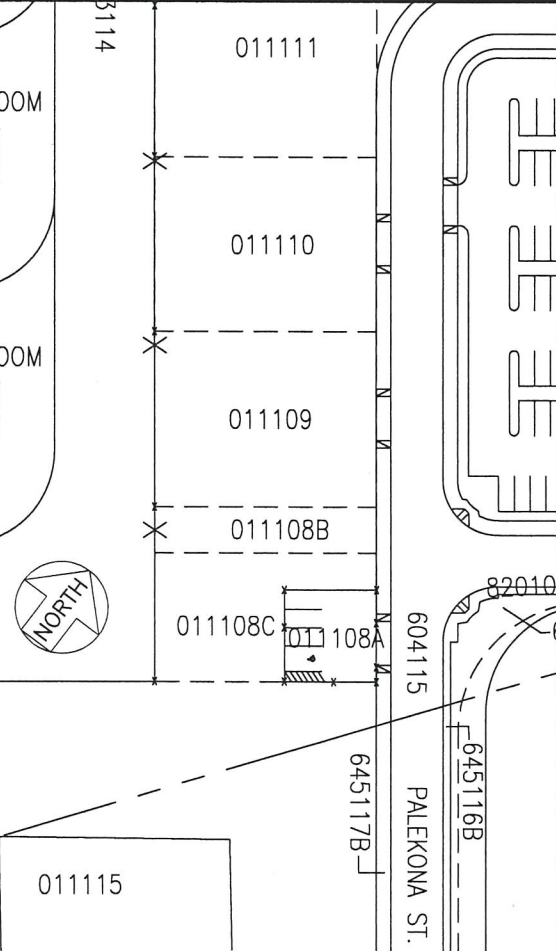
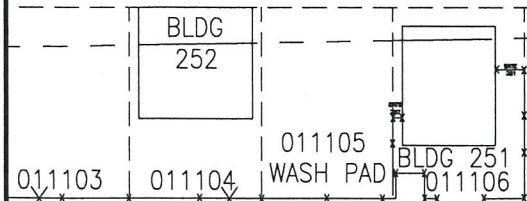
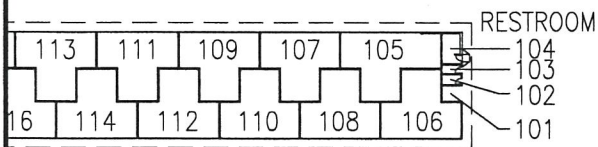
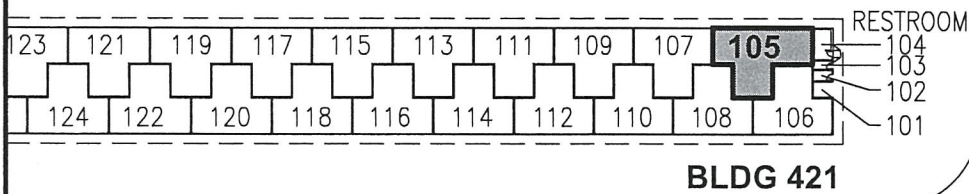
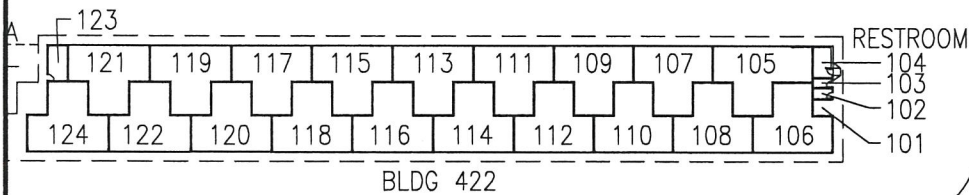




# **LOCATION PLAN**
