#### CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

In accordance with the Exemption List for the Department of Land and Natural Resources, concurred and reviewed by the Environmental Council on June 5, 2015, the subject request is exempt from the preparation of an environmental assessment pursuant to Exemption Class No. 1, "Operations, repairs, or maintenance of existing structures, facilities, equipment, or topographical features, involving negligible or no expansion or change of use beyond that previously existing," Item 51 that states, "permits, licenses, registrations, and rights-of-entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing." ### **REMARKS:**

Waikiki Beach Activities, Ltd. is requesting a right-of-entry permit at the man-made island of the Duke Kahanamoku Lagoon as depicted on Exhibit A to place a directional sign in relation to the luau to be held on the abutting hotel property. The planned reception for the Princess House group will be held at the hotel, and the anticipated number of participants is about 500.

The sign, "Princess House", will be made of Styrofoam with a height of 60 inches and between 35 to 43 inches wide depending on the letter. The sign will be facing the hotel where the reception will be held and stand firmly on the island though the use of base plate. An artist rendering is attached as **Exhibit C**. Applicant will monitor the event and the

installation of the requested sign during the event.

Applicant has not had a lease, permit, easement or other disposition of State lands terminated within the past five years due to non-compliance with such terms and conditions. Office of Conservation and Coastal Lands and Division of Boating and Ocean Recreation have no objection to the subject request and concur to the proposed environmental assessment exemption declaration.

There are no other pertinent issues or concerns, and staff does not have any objection to the request.

#### RECOMMENDATION: That the Board:

- 1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
- 2. Authorize the issuance of a right-of-entry permit to Waikiki Beach Activities, Ltd. covering the subject area for placing sign purposes under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
  - A. The standard terms and conditions of the most current right-of-entry permit form, as may be amended from time to time;
  - B. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.

In accordance with the Exemption List for the Department of Land and Natural Resources, concurred and reviewed by the Environmental Council on June 5, 2015, the subject request is exempt from the preparation of an environmental assessment pursuant to Exemption Class No. 1, that states "Operations, repairs, or maintenance of existing structures, facilities, equipment, or topographical features, involving negligible or no expansion or change of use beyond that previously existing," Item 51 that states, "permits, licenses, registrations, and rights-of-entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing."

The Board has previously permitted beach activities events in the past. The request is indirectly involved in a beach activities event to be held on the adjacent private hotel property. Public access to the shoreline will not be affected by the installation of the subject sign. As such, staff believes that the request will involve negligible or no expansion or change in use beyond that previously existing.

Cumulative Impact of Planned Successive Actions in Same Place Significant? No successive actions will occur in the same location. As such, staff believes that there would be no significant cumulative impact.


