REQUEST:

Issuance of a Revocable Permit for Aircraft Parking (parking permit) to Chaitan Ward and Richard Fant, situated at Ellison Onizuka Kona International Airport at Keāhole.

LEGAL REFERENCE:

Sections 171-55, Hawai'i Revised Statutes.

APPLICANT:

Chaitan Ward and Richard Fant, whose mailing address is PO Box 198900 #307, Hawai'i 96719.

LOCATION AND TAX MAP KEY:

Portion of Ellison Onizuka Kona International Airport at Keāhole (KOA), Kailua-Kona, Island of Hawai'i, identified by Tax Map Key: 3rd Division, 7-3-43: Portion of 40.

Area/Space No. 407-117, containing an area of approximately 990 square feet, as shown on the attached Exhibit A.

within Exemption Class #1, Comprehensive Exemption List for the State of Hawai‘i, Department of Transportation, dated November 15, 2000, as approved by the Environmental Quality Council. Exemption Class #1 covers operations, repairs, or maintenance of existing structures, facilities, equipment, or topographical features involving negligible or no expansion or change of use beyond that previously existing.

The DOTA consulted with the U.S. Federal Aviation Administration as to the appropriateness of the citation of the Environmental Exemption Class from the Comprehensive list for the Department of Transportation dated November 15, 2000. In this case, the FAA concurred on the appropriateness.


REMARKS:

The issuance of a parking permit to Chaitan Ward and Richard Fant at Ellison Onizuka Kona International Airport at Keāhole complies with Chapter 343, Exemption Class 1.d.10 as a continuing aeronautical use, and is in accordance with Section 171-55 HRS, relating to Permits.

RECOMMENDATION:



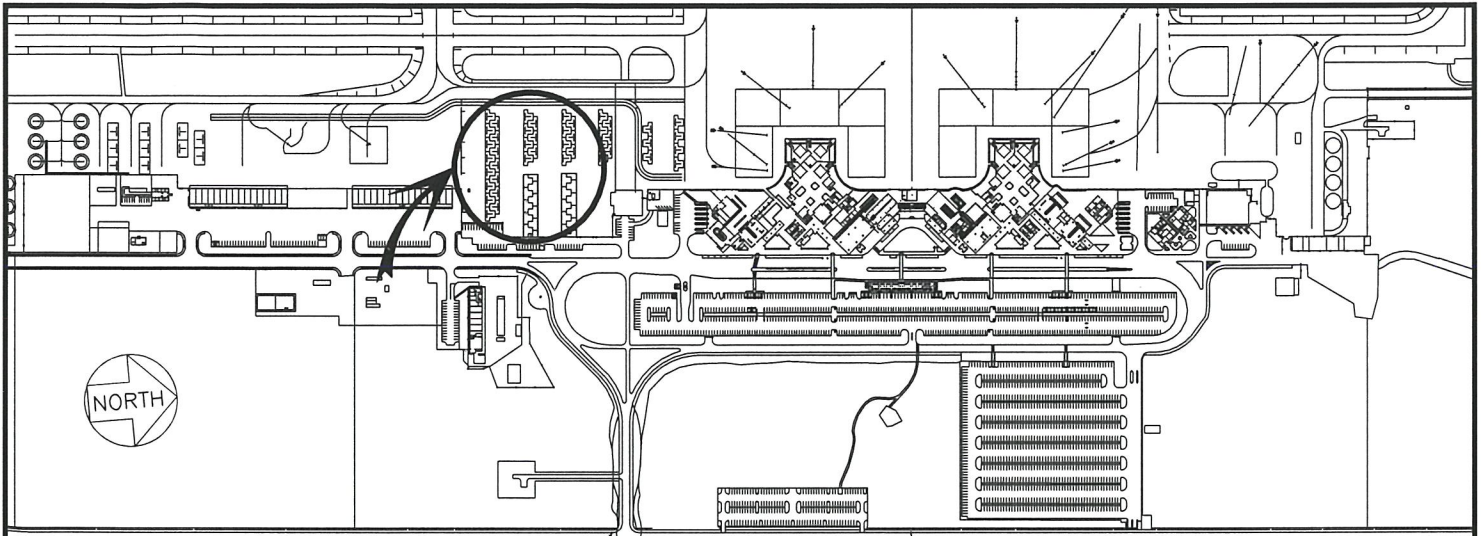

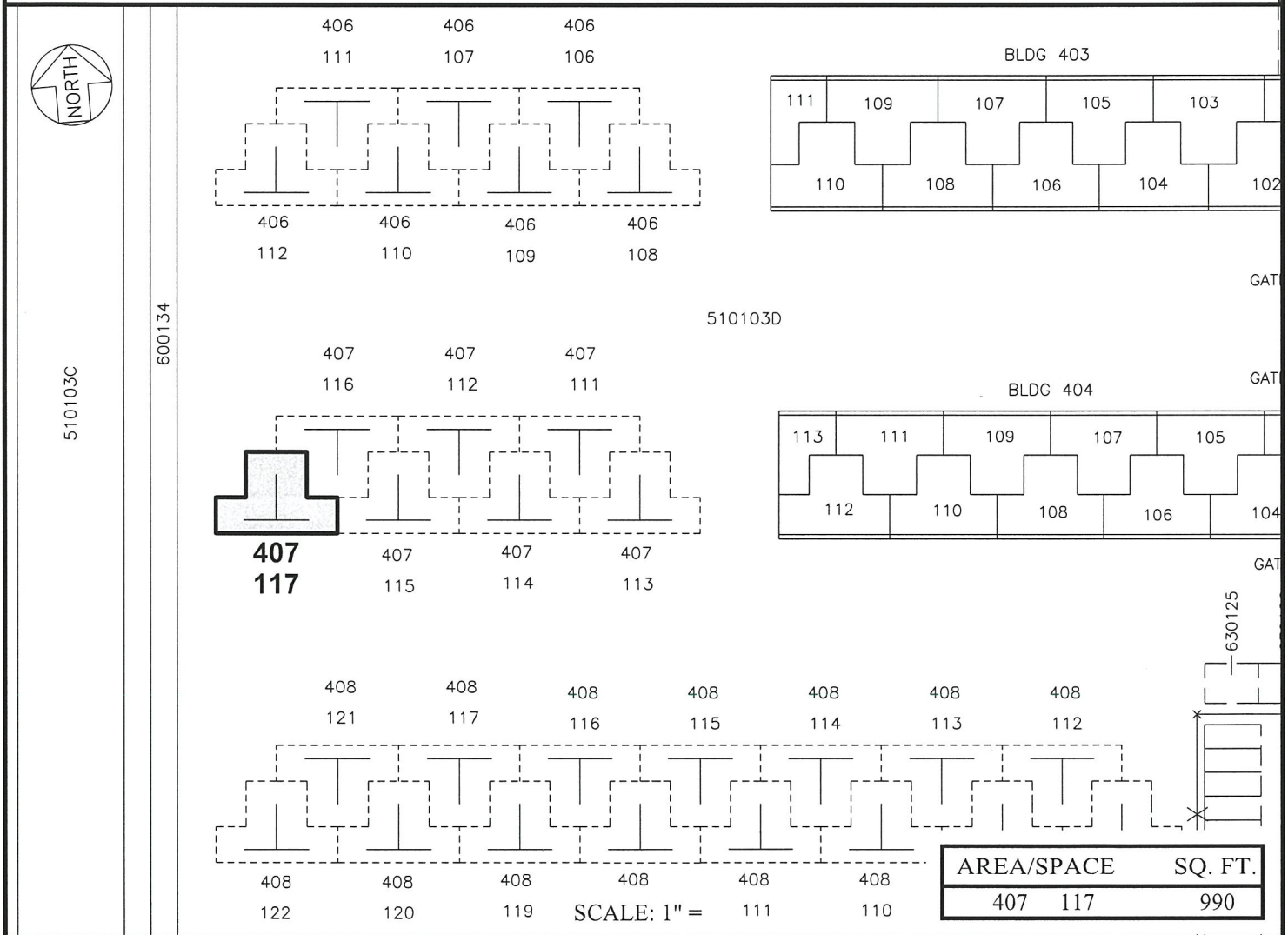
