Set-up, break-down, and clean-up for food and beverage event.

#### TERM:

Between 8:00 a.m. to 11:00 p.m., Friday, April 26, 2019.

#### **RENTAL:**

Based on reciprocating financial benefits to the community, staff recommends gratis charge. See Remarks section.

#### CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

In accordance with Section 11-200-8, Hawaii Administrative Rules (HAR), and the Exemption List for the Department of Land and Natural Resources approved by the Environmental Council and dated June 5, 2015, the subject request is exempt from the preparation of an environmental assessment pursuant to Exemption Class No. 1, Item 51, which states the "Permits, licenses, registrations, and rights-of-entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing". See **Exhibit B**.

#### **REMARKS:**

Around 1963, the developer of the abutting hotel parcel obtained approval from the State to

excavate the rock coastline and develop a beach and two small islets. The Board approved the agreement at its meeting on January 25, 1963. Subsequent to 1968, revocable permits were issued to the respective hotel owners over the subject location for recreational and maintenance purposes.

Hawaii Food & Wine Festival (HFWF) is requesting the issuance of a right-of-entry permit for the set-up, break-down, and clean-up of a food and beverage event in the grass area fronting the Kahala Hotel occurring on April 26, 2019 (see **Exhibit C**). HFWF is requesting the use of 1,543 square feet of State land to set-up a stage, tents, tables and other related items to host the event. The event duration will be from 8:00 a.m. to 11:00 p.m., Friday, April 26, 2019.

The event is a food and wine tasting occasion, which means alcoholic beverages (including beer) are planned on being served and consumed on State lands. Staff is requesting the Board remove the right-of-entry (ROE) permit condition, for this event, which states:

"No alcoholic beverages shall be served or permitted in the right-of-entry area or premises."

At its meeting on November 9, 2018, item D-18, the Board requested that a public access pathway of at least 20 feet be placed between rented areas. Staff has informed the applicant to maintain a 20 feet space between non-connecting tents (see **Exhibit D**).

Also, due to the large reciprocating financial benefit to the community, staff is recommending that the charge be gratis to cover the exclusive use of the requested area. In 2018, almost \$385,000 was given to 23 non-profit community partners (see **Exhibit E**).

The applicant also requests the use of a truck to tow and place the Airstream into position, and to remove the Airstream after the event. The truck will not be attached to the Airstream during the event (see **Exhibit F**, Airstar also included).

The Applicant will provide a courtesy notice to the manager of the adjacent Kahala Beach Condominium, who will post the notice on the bulletin board within the condominium regarding the April 26, 2019 event.

Applicant has not had a lease, permit, easement or other disposition of State lands terminated within the past five years due to non-compliance with such terms and conditions. OCCL has no comments on the subject request. Staff does not have any objection to this request. There are no pertinent issues or concerns.

#### RECOMMENDATION: That the Board:

1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.

- 2. Authorize the issuance of a ROE permit to Hawaii Food & Wine Festival covering the subject area for food and beverage event purposes under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
  - A. The standard terms and conditions of the most current right-of-entry permit form, as may be amended from time to time; and
  - B. Authorize the Applicant to serve alcoholic beverage at the subject event, subject to Applicant's obtaining the respective authorizations from the Liquor Commission; and
  - C. One (1) truck is allowed to position and remove the Airstream before and after the event; and
  - D. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.



In accordance with Hawaii Administrative Rule Section 11-200-8 and the Exemption List for the Department of Land and Natural Resources concurred with by the Environmental Council and dated June 5, 2015, the subject request is exempt from the preparation of an environmental assessment pursuant to Exemption Class No. 1, Item 51, which states the "Permits, licenses, registrations, and rights-of-entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing".

Cumulative Impact of Planned Successive Actions in Same Place Significant?

No, similar events occur at the same location from time to time, but not on a routine or regular basis (e.g., daily or weekly). However, the based on the vendor's clean-up conducted after the event, staff believes that there would be no significant cumulative impact.

Action May Have Significant Impact on Particularly Sensitive Environment? The requested area is a portion of State lands visited by tourists and residents, and is heavily impacted by human activity. Public access across the requested area is maintained by the Kahala Hotel staff. In addition, based on the analysis below, staff believes there would be no significant impact to sensitive environmental or ecological receptors.

Consulted Parties:

Consulted with Office of Conservation and Coastal Lands who has no objections to the subject request and concurs with the exemption for an environmental assessment.

Analysis:

The proposed activity is of a similar type and scope of activities that periodically occurred and continues to occur on this and other State land areas across the State. Such activities have resulted in no known significant impacts, whether immediate or cumulative, to the natural, environmental and/or cultural resources in the area. Staff also believes that the request would involve negligible or no expansion or change in use of the subject area beyond that previously existing.

Recommendation:

It is recommended that the Board find that this project will probably have minimal or no significant effect on the environment and is presumed to be exempt from the preparation of an environmental assessment.


The event is the official launch of the 2019 Hawai'i Food & Wine Festival (HFWF) and provides a myriad of benefits for the people of Hawai'i:
