REQUEST:

Issuance of a revocable permit for ramp space to park ground service equipment for use in air cargo operations at Hilo International Airport.

LEGAL REFERENCE:

Sections 171-11 and 171-55, Hawai'i Revised Statutes (HRS).

APPLICANT:

AEKO KULA, LLC ("AK") whose business address is 50 Elliott Street, Honolulu, Hawai'i 96819.

CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The new cargo building development at ITO was included in the April 2003 Final Environmental Assessment (FEA). The FEA was prepared in support of: (1) Federal actions consisting of approval of the Airport Layout Plan in July, 2013, and (2) the State of Hawai'i actions consisting of environmental approval and construction of proposed

Hilo International Airport Improvements. The FEA was prepared pursuant to Chapter 343, Hawai'i Revised Statutes and the Administrative Rules, Title 11, Chapter 200 of the State of Hawai'i Department of Health.

REMARKS:

The DOT has no objections to AK's request and therefore, in accordance with Sections 171-11 and 171-55, HRS, relating to <u>Public Purposes</u> and <u>Permits</u>, respectively, the DOT proposes to issue a revocable permit to AK.

RECOMMENDATION:

That the Board authorizes the DOT to issue a revocable permit to AK, subject to:

- (1) terms and conditions herein outlined, which are by reference incorporated herein and
- (2) such other terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.
