3,000 square feet.

## **CURRENT USE STATUS:**

Vacant and unencumbered.

## CHARACTER OF USE:

Staging and use of beach volleyball court and related beach activity equipment for one-day beach event.

#### TERM OF RIGHT OF ENTRY:

The applicant has requested the use of the subject area for one day from 8:00am to 6:00pm. Set up will begin at 8:00am with the actual event taking place from 12:00pm to 4:00pm. Clean-up and area restoration shall be completed by 6:00pm. The event will take place on June 4, 2019.

# **CONSIDERATION:**

Payment of \$300.00. Rent based on 10¢ per square foot for one day.

Total area of requested use 3,000 square feet for one day. (3,000 sf x \$0.10 per sf = \$300.00).

# CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

In accordance with Hawaii Administrative Rule Section 11-200-8 and the Exemption List for the Department of Land and Natural Resources approved by the Environmental Council and dated June 5, 2015, the subject request is exempt from the preparation of an environmental assessment pursuant to Exemption Class No. 1, that states "Operations, repairs or maintenance of existing structures, facilities, equipment, or topographical features, involving negligible or no expansion or change of use beyond that previously existing" and Item No. 51, that states "Permits, licenses, registrations and right-of-entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing." #### REMARKS:

Staff is requesting approval for a right-of-entry permit to MC&A, Inc. to utilize a portion (3,000 sq. ft.) of the shoreline at DT Flemings Beach for a beach day event for the Chick-Fil-A Company. The event is scheduled for June 4, 2019. The request is to utilize an area

of the shoreline for beach volleyball court, beach chairs with beach umbrellas, snorkel sets, boogie boards, and air mattresses for group members to utilize.

Staff will require that the applicant provide an individual to monitor all equipment to assure that it is properly stored in an orderly manner within the permitted area while items are not in use.

Applicant has not had a lease, permit, easement or other disposition of State lands terminated within the past five years due to non-compliance with such terms and conditions.

There are no other pertinent issues or concerns. Staff has no objections to this request.

#### RECOMMENDATION: That the Board:

- 1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
- 2. Authorize the issuance of a right-of-entry permit, after-the-fact, to MC&A, Inc. for one-day beach activities event, covering the subject area under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
  - A. The standard terms and conditions of the most current right-of-entry permit form, as may be amended from time to time; and,
  - B. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.




