Portion of State of Hawaii lands within the Wailoa River State Recreation Area, Hilo, Hawaii, identified by Tax Map Key (3) 2-2-013:003 as shown on the attached Exhibit A outlined in red.

#### PURPOSE:

Approve a Revocable Permit for the Hawaii Island Art Alliance (HIAA) which will allow them to conduct various exhibits, workshops, classes and an art fair to raise funds to help support the Wailoa Center with donations and activities to aid the Center.

#### **REMARKS**:

The Wailoa Center has been promoting monthly shows since the mid 1970's and its open nights have more than three hundred (300) people in attendance. The additional help of HIAA will help generate additional interest in the various programs available. The Wailoa Center is a unique feature in our State Park system and has become an important part of the art world on Hawaii Island.

The Hawai'i Island Art Alliance (HIAA) was formed as a support group for the Wailoa Center. It has been supporting the Wailoa Center with donations and labor since February 2015 and recently became a 501 C-3 non-profit organization to further its mission.

HIAA would like to coordinate and conduct fee based educational workshops, classes at an annual art fair. HIAA also hopes to install and manage recycling bins at the Wailoa Center.

Any and all fees charged will be with the written approval of State Parks. HIAA will donate all proceeds in excess of normal operating expenses generated from activities to the Wailoa Center.

#### **Staff Comments**

Staff is recommending approval of the issuance of a Revocable Permit to HIAA to further its efforts to support the Wailoa Center.

#### RECOMMENDATION: That the Board:

- 1. Approve the issuance of a Revocable Permit to the Hawaii Island Art Alliance in their support of the Wailoa Center subject to the following conditions:
- 2. Permittee, its officers, agents, employees, volunteers, consultants, contractors, and/or persons acting for, or on its behalf, shall at all times with respect to the Wailoa River State Recreation Area; a) use due care for public safety; b) agrees to release the State of Hawaii from any claims which Permittee might have against the State of Hawaii arising out of Permittee's occupation or use of the Wailoa River State Recreation Area; and c) shall be responsible for its own acts;
- 3. HIAA shall procure and maintain, at its own cost and expense, in full force and effect throughout the term of this Right of Entry, commercial general liability insurance, in an amount of at least \$1,000,000.00 per occurrence and \$2,000,000.00 aggregate, with an insurance company or companies licensed to do business in the State of Hawaii. The policy or policies of insurance shall name the State of Hawaii as an additional insured.

The policy should also contain the following clause: "It is agreed that any insurance maintained by the State of Hawaii will apply in excess of, and not contribute with, insurance provided by this policy". The insurance shall cover the entire Wailoa river State Recreation Area, including all grounds, buildings and all roadways or sidewalks on or adjacent to the Wailoa River SRA in the use or control of the Permittee;

- 4. The permittee shall immediately provide written notice to the Department should any of the insurance policies evidenced on its Certificate of Insurance form be cancelled, limited in scope, or not renewed upon expiration;
- 5. The Chairperson or her representative is authorized to negotiate all other terms and conditions of the Revocable Permit.
