PURPOSE:

To amend the existing Restaurant and Lounge Concession Lease No. DOT-A-92-0018 at Daniel K. Inouye International Airport for the addition of spaces to offer food and beverage services to the traveling public. Under Article III. (Premises) of the Lease, the specific areas assigned or provided for the concession activity may be changed at the discretion of the Director of Transportation.

Chapter 102 and Section 261-7, Hawai'i Revised Statutes, as amended.

Host International, Inc. (HOST), whose business address is 6905 Rockledge Drive, Bethesda, Maryland 20817.

TERM:

To run for the balance of the term of the existing Concession Lease that expires on April 30, 2029.

ADDITIONAL PREMISES:

Area/Space No. 373-212B, containing an area of approximately 3,284 square feet, and Area/Space No. 373-176M, containing an area of approximately 259 square feet, as delineated on the attached map labeled Exhibits B-59 and B-60 dated May 2019.

IMPROVEMENTS:

Applicant at its own cost and expense shall be responsible for any renovation, upgrade, remodeling and improvements to the additional space.

RENTAL:

No additional square footage floor rent will be charged. All gross receipts generated from the additional space will be included with the gross receipts of the Concession Lease as provided in Article VI. (Rental). However, Lessee shall pay the annual sum of \$15,835.32 for utilities.

Environmental Quality Council. Exemption Class #1 covers operations, repairs, or maintenance of existing structures, facilities, equipment, or topographical features involving negligible or no expansion or change of use beyond that previously existing.

The DOTA consulted with the U.S. Federal Aviation Administration as to the appropriateness of the citation of the Environmental Exemption Class from the Comprehensive list for the Department of Transportation dated November 15, 2000. The FAA concurred on the appropriateness.

REMARKS:

The Department of Transportation and Host International, Inc., entered into that certain Concession Lease No. DOT-A-92-0018, dated March 2, 1993, for the Restaurant and Lounge Concession at Daniel K. Inouye International Airport. The additional spaces will provide travelers with more conveniently located areas near airline gates to purchase food and beverage items.

RECOMMENDATION:

That the Board approve and authorize: (1) the Department of Transportation to amend Article III. (Premises) of the subject Lease as herein outlined, which are by reference incorporated herein; (2) such other terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State; and (3) review and approval by the Department of the Attorney General.
