Chair thanked the Staff and Divisions for working together to work on this proposed solution.

lan Hirokawa, Land Division, passed out a letter a letter from one of the permitees sent to him last night. Provided background on the development of the Watershed Management Protection Plan. Asking for approval of the concept/approach. This does not bond the Board in any way. These are not the final numbers, it is a scenario. Reiterated that these are not the final number, this is at conceptional stage. Permittees are welcome to come up with alternatives. Once they have worked on suitable guidelines, they will come back to Board.

## **Board Discussion**

The Board confirmed that the numbers in the chart are not final and that they are based on current trends, and what they are trying to do is provide a conceptual plan to that will help lead us in the direction of creating long-term leases. There was a robust discussion regarding moving the revocable permits to long-term water leases and how to define a process along with the importance of the Water Shed Plans.

Scott Press, DOFAW, the proposal looks at the water shed plan and protecting the forest to manage the watershed, so we can continue to produce the water that we are using.

## Public Testimony

Ann Fredrick, HAPA, reject the submittal, suggests a more comprehensive rule-making approach relating to cost share formula and water shed management.

Don Heacock, Fisheries Biologist, this is public trust issue as well. Has has not found a watershed plan he likes, we should restore the watershed not just protect it. Waialeale and Waikoko are a public trust and should be beneficial for the public.

Simon Russell, Farm Maui LLC, supports water leases, IFFS crucial to this.

Sharon Suzuki, Hawaii Electric Light, would like to see this deferred. Gave a brief summary of her written testimony.

Bridget Hammerquist, felt we were putting the cart before horse. Identify what needs to be in the watershed plan. Provided written testimony.

Alika Atay- highlighted what it takes to measure and sustain in the stream.

Warren Watanabe, Hawaii Farm Bureau read his written testimony.

Leimana DeMate, Aha Moku, the islands that have responded basically supports the concept of the submittal, although they would like to see Exhibit A removed as it is confusing.

Donald Cabebe, he would like to see a rulemaking process. Watershed plan should be comprehensive, stands by his written testimony.

James Manaku, would like assurances that there be access for practitioners to gather.

Leinaala Ley -Earthjustice, supports rule-making with public input and a lease by lease formula.
