#### TERM OF RIGHT-OF-ENTRY:

One day event scheduled for September 14, or 15, 2019 with alternate dates of September 21, 22, 28, or 29, 2019. Alternate dates will apply subject to weather and or surf conditions.

#### CONSIDERATION:

Payment of \$150.00. Rent based on 10¢ per square foot per day. Total area of requested use is 1,500 square feet. (200 sf x 10¢ ft./day = \$20.00).

In accordance with Hawaii Administrative Rules (HAR) Section 11-200-8 and the Exemption List for the Department of Land and Natural Resources approved by the Environmental Council and dated June 5, 2015, the subject request is exempt from the preparation of an environmental assessment pursuant to Exemption Class No. 1, that states "Operations, repairs or maintenance of existing structures, facilities, equipment, or topographical features, involving negligible or no expansion or change of use beyond that previously existing" and Item No. 51, that states "Permits, licenses, registrations and right-of-entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing." - 2. Obtain Right-of-Entry permit signed by the Chairperson from the Maui District Land Office.
- 3. Supply Certificate of Insurance naming the State of Hawaii as additional insured.
- 4. Obtain DOBOR Ocean activity permit for water/ocean portion of this event.
- 5. Monitor all equipment to assure proper use and storage in an orderly manner permitted area.

The Hawaii Surfing Association Maui has requested the use of a portion of

## **REMARKS:**

The Hawaii Surfing Association Maui has requested the use of a portion of unencumbered government land in an area above the shoreline at Koki Beach, Hana, Maui. The Hawaii Surfing Association Maui will be hosting their annual amateur surf competition. Two (2) 10'x10' pop up tents will be erected within the requested area of use for event operations during the competition. 1,100 square feet of space has been allotted for use in between and around the two tents to allow for event staging and operation purposes for a total of 1,500 square feet of area use.

Through this event, and others like it, amateur surfers are afforded an opportunity to experience friendly competition. Surfing is promoted in a positive manner with respect to fellow competitors as well as the ocean and land areas being utilized for these competitions.

Applicant has not had a lease, permit, easement or other disposition of State lands terminated within the past five years due to non-compliance with such terms and conditions. There are no other pertinent issues or concerns. Staff has no objections to this request.

# **RECOMMENDATION**: That the Board



Cumulative Impact of Planned Successive Actions in Same Place Significant? Not applicable. Use of this area is not on a routine or regular basis.

Action May Have Significant Impact on Particularly Sensitive Environment? DLNR staff believes there is no significant impact to sensitive environmental or ecological receptors.

Agencies Consulted:

The DLNR Office of Conservation and Coastal Lands, Division of Boating and Ocean Recreation, and Division of Aquatic Resources were consulted with regard to the proposed activity at the subject area.

Analysis:

Such activities have resulted in no known significant impacts, whether immediate or cumulative, to the natural, environmental and/or cultural resources in the area.

Findings:

Staff believes that the request would involve negligible or no expansion or change in use of the subject area beyond that previously existing.

Recommendation:

It is anticipated that these periodic beach events will probably have minimal or no significant effect on the environment and is presumed to be exempt from the preparation of an environmental assessment.
