#### APPLICANT:

Blue Dolphin Charters, Ltd. (Applicant) is a domestic profit corporation whose business registration and mailing address is P.O. Box 869, Eleele, Hawaii 96705.

## CHARACTER OF USE:

Storage of tools, equipment and supplies for tour boat operations, and minor repairs.

Portion of governmental lands, inside the Warehouse Shed, Port Allen Harbor, Kauai, Tax Map Key No. (4) 2-1-003:006 (P), Governor's Executive Order No. 1047, as shown on the attached map labeled Exhibit A.

# **CURRENT USE STATUS:**

The Applicant currently has an existing month-to-month permit that occupies a portion of the Warehouse Shed at Port Allen Harbor, Kauai, for storage of tools, equipment and supplies. The Department of Transportation, Harbors Division (DOT Harbors) has been reviewing all month-to-month permits to ensure compliance with and applicability to Sections 171-17 and 171-55, HRS. The DOT Harbors is updating the Applicant's permit with current appraised rates and updated permit terms (as applicable).

#### LAND TITLE STATUS:

Governor's Executive Order No. 1047 for Port Allen Harbor, to be under the control and management of the Department of Transportation, Harbors Division (DOT Harbors).

## CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

This use is exempt from the Office of Environmental Quality Control (OEQC) requirements pursuant to Chapter 11-200.1, Hawaii Administrative Rules, "Exemption Class 1: Operations, repairs or maintenance of existing structures, facilities, equipment or topographical features, involving negligible or no expansion or change of use beyond that previously existing."

Declaration of Exemption was published with the OEQC in *The Environmental Notice* on September 23, 2019.

# REMARKS:

Currently, the Applicant has an existing month-to-month permit to store tools, equipment and supplies in the Warehouse Shed, Port Allen Harbor, Kauai. The DOT Harbors has been reviewing all month-to-month permits to ensure compliance with and applicability to Sections 171-17 and 171-55, HRS.

The existing month-to-month permit was issued on August 1, 2000, and rent is currently \$553.50 per month. This Submittal will update and renew the month-to-month permit which is compliant with Chapter 171, HRS.




