LEGAL REFERENCE:

Sections 171-6, 171-13, 171-17, 171-55, and 171-59, Hawaii Revised Statutes (HRS), as amended.

APPLICANT:

Catamaran Kahanu, Inc. (Applicant) is a domestic profit corporation whose business registration and mailing address is P.O. Box 51006, Eleele, Hawaii 96705.

CHARACTER OF USE:

Storage of canned soda, juice, paper goods, engines and engine parts. No repairs or maintenance allowed on the premises.

LOCATION:

Portion of governmental lands, inside the former Fumigation Shed, Port Allen Harbor, Kauai, Tax Map Key No. (4) 2-1-003:006 (P), Governor's Executive Order No. 1047, as shown on the attached map labeled Exhibit A.

COMMENCEMENT DATE:

TRUST LAND STATUS:

Subsection 5(a) of the Hawaii Admission Act (Non-ceded Lands).

CURRENT USE STATUS:

The Applicant currently has an existing month-to-month permit that occupies a portion of the former Fumigation Shed, Port Allen Harbor, Kauai, for storage of canned soda, juice, paper goods, engines and engine parts. The Department of Transportation, Harbors Division (DOT Harbors) has been reviewing all month-to-month permits to ensure compliance with and applicability to Sections 171-17 and 171-55, HRS. The DOT Harbors is updating the Applicant's permit with current appraised rates and updated permit terms (as applicable).

LAND TITLE STATUS:

Governor's Executive Order No. 1047 for Port Allen Harbor, to be under the control and management of the Department of Transportation, Harbors Division (DOT Harbors).

CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

This use is exempt from the Office of Environmental Quality Control (OEQC) requirements pursuant to Chapter 11-200.1, Hawaii Administrative Rules, "Exemption Class 1: Operations, repairs or maintenance of existing structures, facilities, equipment or topographical features, involving negligible or no expansion or change of use beyond that previously existing."

Declaration of Exemption was published with the OEQC in *The Environmental Notice* on September 23, 2019.

REMARKS:

Currently, the Applicant has an existing month-to-month permit for storage of canned soda, juice, paper goods, engines, and engine parts, in the former Fumigation Shed, Port Allen Harbor, Kauai. The DOT Harbors has been reviewing all month-to-month permits to ensure compliance with and applicability to Sections 171-17 and 171-55, HRS.

The existing month-to-month permit was issued on December 1, 2000, and rent is currently \$112.00 per month. This Submittal will update and renew the month-to-month permit which is compliant with Chapter 171, HRS.

RECOMMENDATION:





