
REMARKS:

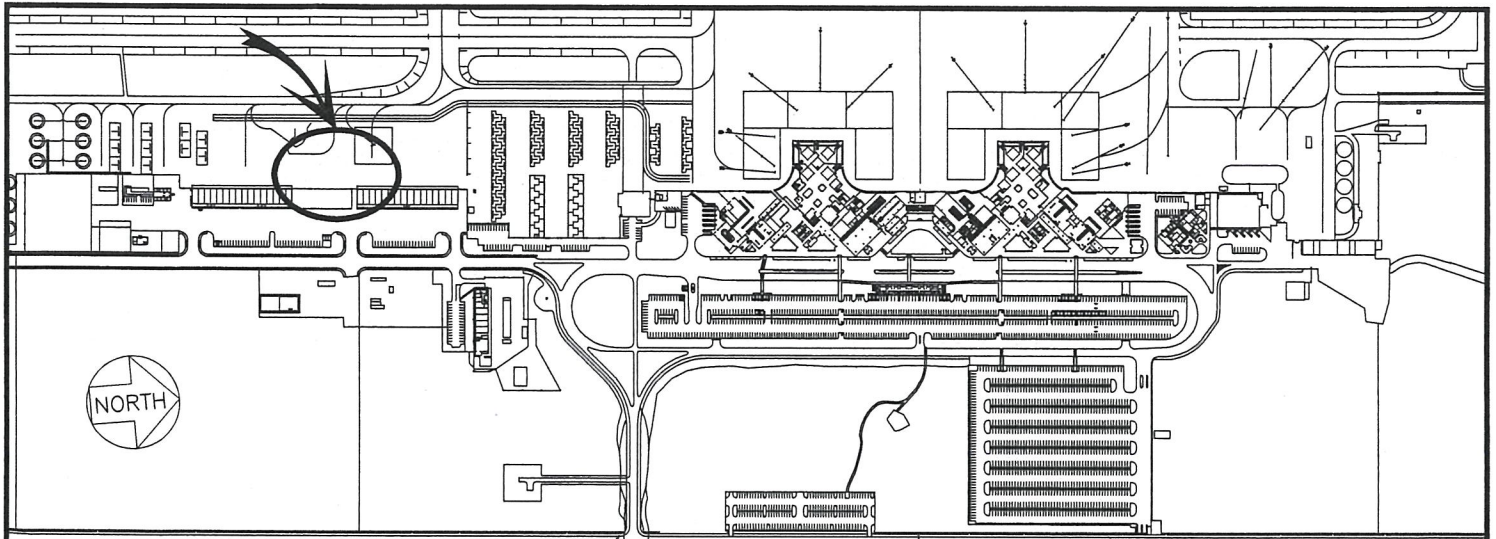

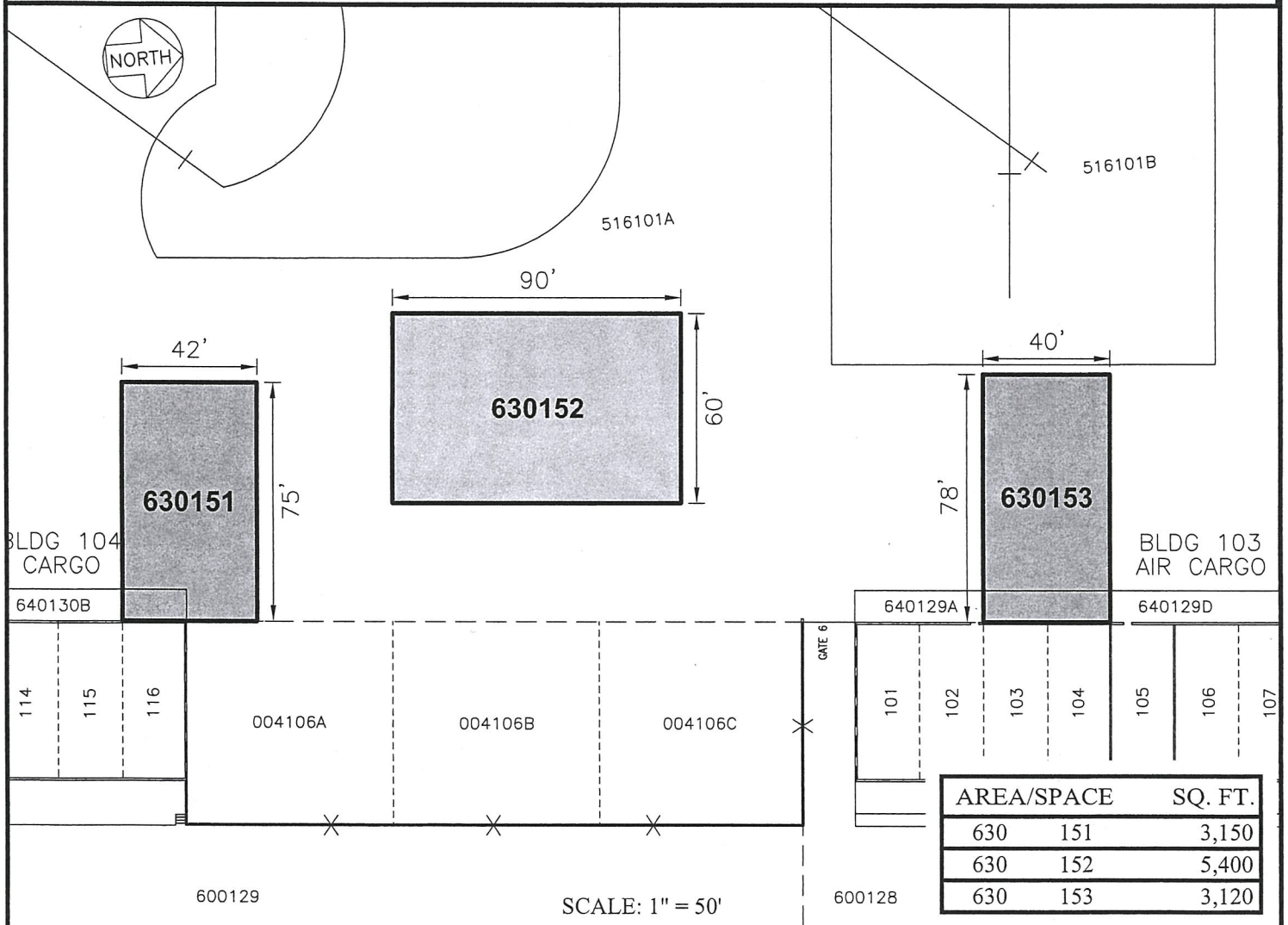
