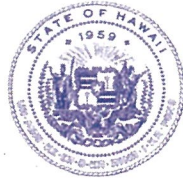

REQUEST:

Issuance of a revocable permit to Hawaiian Airlines, Inc. (HAL) for the storage of ground service equipment (GSE) at Līhu'e Airport.

environmental impact statement as required by Chapter 343, Hawaii Revised Statutes, as amended, relating to Environmental Impact Statements, because the proposed action falls within Exemption Class #1, Comprehensive Exemption List for the State of Hawaii, Department of Transportation, dated November 15, 2000, as approved by the Environmental Quality Council. Exemption Class #1 covers operations, repairs, or maintenance of existing structures, facilities, equipment, or topographical features involving negligible or no expansion or change of use beyond that previously existing.

The DOTA consulted with the U.S. Federal Aviation Administration as to the appropriateness of the citation of the Environmental Exemption Class from the Comprehensive list for the Department of Transportation dated November 15, 2000. In this case, the FAA concurred on the appropriateness.

REMARKS:

In accordance with Sections 171-11 and 171-55, HRS, relating to Public Purpose and Permits, respectively, the Department of Transportation proposes to issue a month-to-month revocable permit to HAL for the storage of ground service equipment as part of their Signatory Airline Carrier Operations at Līhu‘e Airport.

RECOMMENDATION:



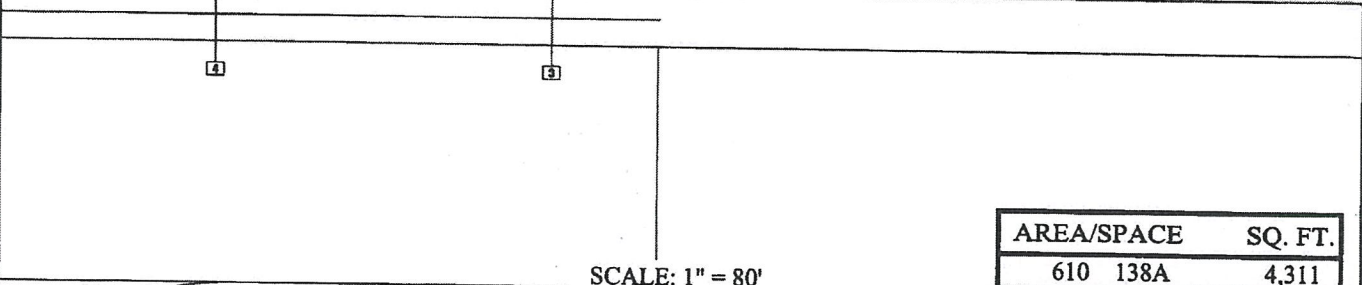
