Wayne Tanaka, OHA- Strongly Support. Easement is a good start. Read his written Testimony. Case thanked him for all the research that they did.

*Chris Kobayashi*, 3<sup>rd</sup> generation kalo farmer. 30 years ago, made a commitment to farm her father's land. Quality of taro is not as good due to the silt that was brought by the flood last year.

Bobby Watari, supports the submittal.

Kaisen Carillo-next generation, came to Oahu to work when he was old enough and then went back to Kauai. In support of the easement

Sierra Boro Harada, next generation took over the farm when her grandfather got sick. In support of the easement.

Kapua Sproat, in Professional capacity in Hawaiian Law. Worked in partnership with the Hui this semester. Will continue to help move forward on the water lease.

Uiilani Tanagawa – Lum, Environmental law, worked with Hui, frustrating to see the struggles between government and process to get access. Longstanding understanding of the Kalo farmers.

Ed Underwood, Division of Boating and Ocean Recreation presented the submittal. Representatives from Kama'aina Care Inc., are present.

# Applicant:

Greg Krugle, Counsel, and Ray Sanborn, President for Kama'aina Care Inc. Sanborn provided history of the program at Heeia State Park. The kayak tours provide revenue to maintain the park and a lot of the money goes back into the park. Interpretation of the Regional rules.

Greg Krugle noted it wasn't till recently there was a discussion whether Kama'aina Care, needed a commercial permit for its bay activities. In 2017 a determination was made that they needed a permit. In March 2018, DOBOR issued a permit, there were many discussions regarding the pricing of their activities. In February 2019 they received a letter from DOBOR, stating their commercial permit would not be renewed. We did not agree with their determination for not renewing. He went on to explain their position and the impacts and are seeking an administrative hearing.

Krugle confirmed that they did not re-apply for a permit when they asked. They do not see their tours as commercial, but as educational. They want a dual process.

#### **Board Discussion**

Roehrig's concern was the impact this would have on the children's programs. The discussion continued regarding the merits of making money for 501C's.

Krugle noted that they have been working with Kaneohe Base Council and try to find different ways to comply.

There continued to be a robust discussion on compliance and finding solutions that everyone can live with.

Roehrig suggested to defer and mediate.
