Weil & Associates, Inc., a domestic profit corporation.

LOCATION:

Portion of Government lands situated at Wailea Beach, Wailea, Honuaula, Maui, identified by Tax Map Key: (2) 2-1-008: Seaward of 089, as shown on the attached map labeled Exhibit A.

AREA:

15,625 square feet, more or less (Exhibit B) (125' x 125' participants'/officials' tents, volleyball court)

CHARACTER OF USE:

Beach Volleyball Clinic Purposes.

TERM OF RIGHT-OF-ENTRY:

This is a two-day event scheduled for February 27 and 28, 2020 from 6:00 a.m. to 1:30 p.m. on both days.

CONSIDERATION:

Total Cost: \$3,125.00 for 2 days of beach volleyball clinics. 15,625 sq. ft. x \$0.10 per square foot per day = \$1,562.50 per day x 2 days = \$3,125.00 (Three thousand, one hundred twenty-five dollars).

CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:

In accordance with Hawaii Administrative Rules (HAR) Section 11-200.1-15 and the Exemption List for the Department of Land and Natural Resources (DLNR) approved by the Environmental Council and dated June 5, 2015, the subject request is exempt from the preparation of an environmental assessment pursuant to Exemption Class No. 1, that states "Operations, repairs or maintenance of existing structures, facilities, equipment, or topographical features, involving negligible or no expansion or change of use beyond that previously existing" and Item No. 51, that states "Permits, licenses, registrations, and right-of-entry issued by the Department that are routine in nature, involving negligible impacts beyond that previously existing." REMARKS:

Staff is requesting approval for a right-of-entry permit to Weil & Associates, Inc., for a beach volleyball clinic scheduled on February 27 and 28, 2020, from 6 a.m. to 1:30 p.m. on both days. Cleanup and restoration of the area to be completed by sunset. Staff brings this request to the Board pursuant to the policy adopted at its meeting of June 14, 2013 under agenda Item D-11.

The proposed activity is similar in type and scope of beach activities that periodically occurred and continue to occur at this and other beach areas in south Maui. Such activities have resulted in no known significant impacts, whether immediate or cumulative, to the natural, environmental and/or cultural resources in the area. As such staff believes that the proposed event/use would involve negligible or no expansion or change in use of the subject area beyond that previously existing.

Applicant has not had a lease, permit, easement or other disposition of State lands terminated within the past five years due to non-compliance with such terms and conditions.

RECOMMENDATION: That the Board,

- 1. Declare that, after considering the potential effects of the proposed disposition as provided by Chapter 343, HRS, and Chapter 11-200.1, HAR, this project will probably have minimal or no significant effect on the environment and is therefore exempt from the preparation of an environmental assessment.
- 2. Authorize the issuance of a Right-of-Entry permit to Weil & Associates, Inc. covering the subject area for beach volleyball clinic purposes under the terms and conditions cited above, which are by this reference incorporated herein and further subject to the following:
 - A. The standard terms and conditions of the most current right-of-entry permit form, as may be amended from time to time, and
 - B. Such other terms and conditions as may be prescribed by the Chairperson to best serve the interests of the State.



Project Description:

Use of 15,625 sq. ft. of beach area for two-day beach volleyball clinic on February 27 and 28, 2020, from 6 a.m. to 1:30 p.m. on both days. Beach area to be cleared and restored to original

condition or better by end of day.

Chap. 343 Trigger(s):

Use of State Land

Exemption Class No. and Description:

In accordance with Hawaii Administrative Rule Section 11-200-1.15 and the Exemption List for the Department of Land and Natural Resources concurred with by the Environmental Council and dated June 5, 2015, the subject request is exempt from the preparation of an environmental assessment pursuant to Exemption Class No. 1, that states "Operations, repairs or maintenance of existing structures, facilities, equipment, or topographical features, involving negligible or no expansion or change of use beyond that previously existing" and Item No. 51, that states "Permits, licenses, registrations, and right-of-entry issued by the Department that are routine in nature, involving negligible impacts beyond that

previously existing."

Cumulative Impact of Planned Successive Actions in Same Place Significant: No, this event occurs at this location annually, not on a routine or regular basis (e.g., daily or weekly).

Action May Have Significant Impact on Particularly Sensitive Environment: The requested area is a portion of unencumbered State coastal land visited daily by tourists and residents and is used for recreational activity. In addition, based on the analysis below, staff believes there would be no significant impact to sensitive environmental or ecological receptors.

Agencies Consulted:

The DLNR Office of Conservation and Coastal Lands (OCCL) was consulted with regard to the subject beach volleyball clinic and MDLO staff's recommendation for an exemption from an environmental assessment. OCCL staff responded that they have no objections to the subject beach volleyball clinic.

Analysis:

The Board has permitted similar events in the past. The proposed activity is of a similar type and scope of coastal activities that periodically occurred and continue to occur on this and other coastal areas across the State. Such activities have resulted in no known significant impacts, whether immediate or cumulative, to the natural, environmental and/or cultural resources in the area. Staff also believes that the request would involve negligible or no expansion or change in use of the subject area beyond that previously existing.

Recommendation:

It is anticipated that this beach volleyball clinic will probably have minimal or no significant effect on the environment and is presumed to be exempt from the preparation of an environmental assessment.
