The area is located on the Island of Oahu.

AREA:

Interstate Highway, I-H1-1(23), TMK: (1) 2-4-011:114 is approximately 37,507 square feet.

ZONING:

TMK: (1) 2-4-011:114 (Oahu) is zoned as "Commercial".

CURRENT USE STATUS:

The area is currently vacant. However, the area was previously leased to a private storage business from 1987 to 2019. The area has been previously paved with asphalt and has fencing surrounding the perimeter of the property.

COMMENCEMENT DATE:

Upon receipt of all approvals from the Board of Land and Natural Resources, the Federal Highway Administration (FHWA), and full execution of the RP.

COMPENSATION:

Gratis. The use of the property by the SPO is by a governmental agency for public use and is exempt from any fair market value requirements, pursuant to 23 CFR 710.403 (d) (1).

LIENS AND/OR ENCUMBRANCES:

None.

CHAPTER 343 – ENVIRONMENTAL ASSESSMENT:

Pursuant to Section 11-200-8, Hawaii Administrative Rules, the use by SPO is exempt from the preparation of an Environmental Assessment based on the attached Comprehensive Exemption List for the State Department of Transportation dated November 15, 2000. More specifically, Exemption Class 3 for "Construction and location of new, small facilities or structures and the alteration and modification of same and installation of new small, equipment and facilities and the alteration and modification including, but not limited to:

- (c) Stores, offices and restaurants designed for total occupant load of twenty persons or less, if not in conjunction with the building of two or more such structures;
- (d) Water, sewage, electrical, gas, telephone and other essential public utility services extensions to serve such structures or facilities;"

<u>REMARKS</u>:

In accordance with Section HRS 171-55 relating to Permits, the State Department of Transportation, Highways Division proposes to issue a month-to-month RP to SPO for storing of personal property from homeless sweeps and for parking and office purposes.

RECOMMENDATION:

Authorize the issuance of RP HY 20-152 to SPO within Interstate Highway, Project No. I-H1-1(23) at Pele Street to Keeaumoku Street, Honolulu, Oahu, Hawaii, TMK: (1) 2-4-011:114 for storage, parking and office purposes, subject to the following:

- 1) Final approval of the RP will be subject to prior approval from FHWA.
- 2) All SPO improvements installed/constructed within the State right-of-way will be subject to prior review and approval from DOT.


