The DOTA consulted with the U.S. Federal Aviation Administration (FAA), as to the appropriateness of the citation of the Environmental Exemption Class from the Comprehensive list for the Department of Transportation dated November 15, 2000. In this case, the FAA concurred on the appropriateness.

REMARKS

This permit allows EAN Holdings, LLC dba Enterprise Rent a Car at Kahului Airport, Ellison Onizuka Kona International Airport at Keāhole, Hilo International Airport, Līhu‘e Airport and Moloka‘i Airport to continue operations at the Airports.

RECOMMENDATION:

That the Board authorize the Department of Transportation to issue month-to-month revocable permits to EAN Holdings, LLC dba Enterprise Rent A Car, subject to:
(1) terms and conditions herein outlined, which are by reference incorporated herein; and
(2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.

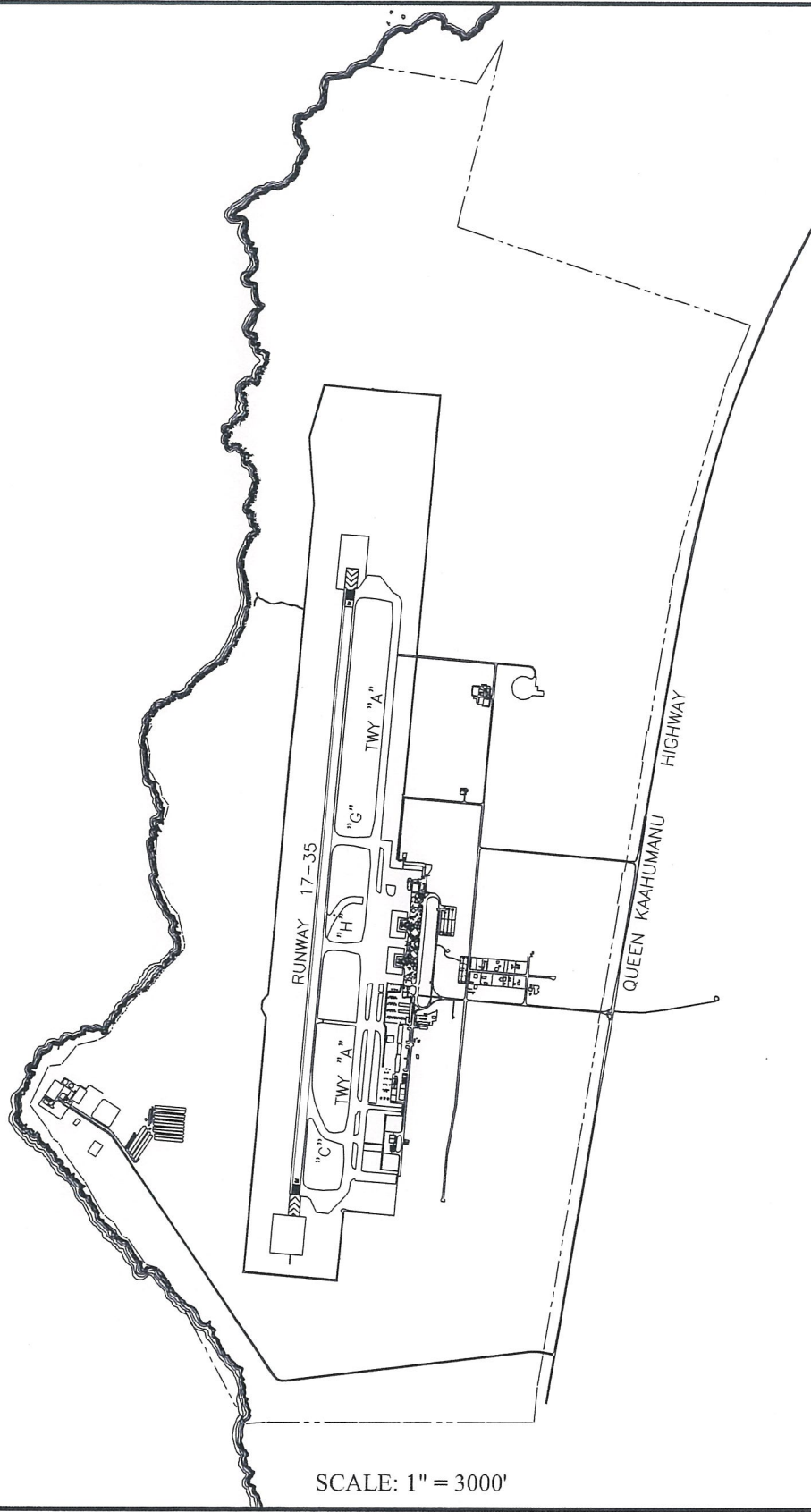

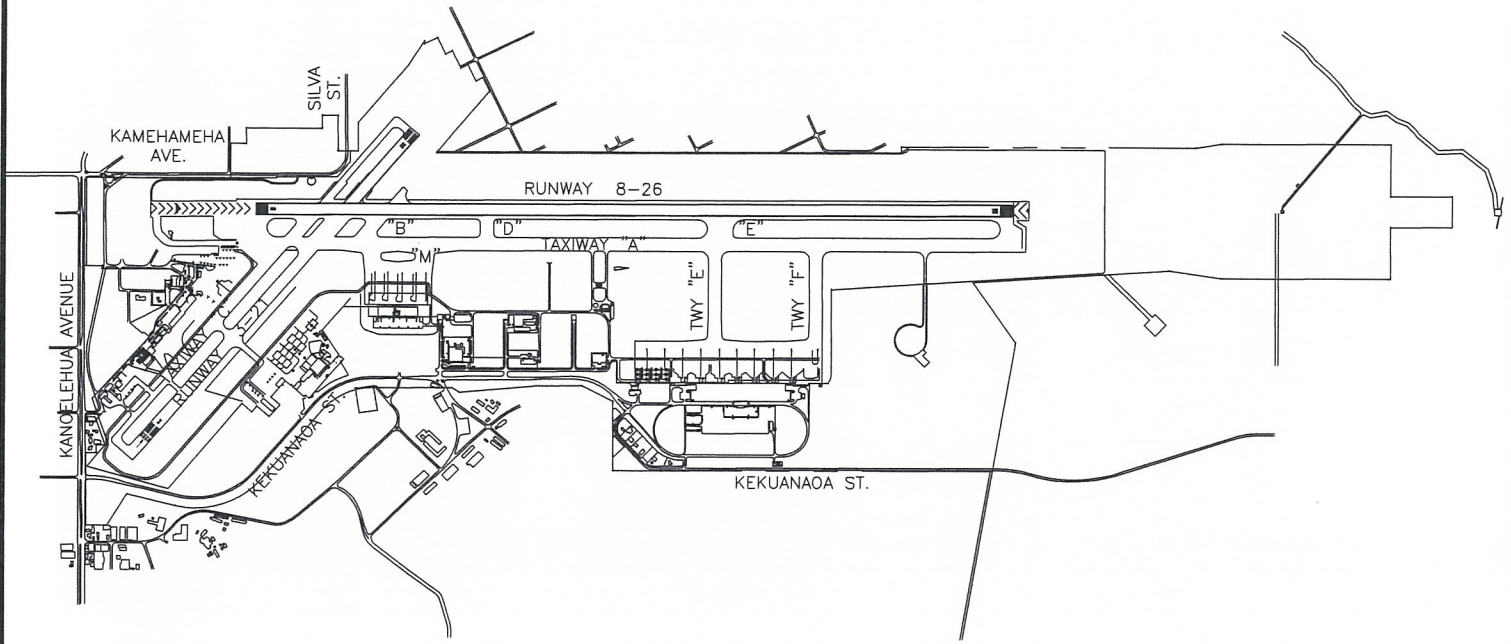

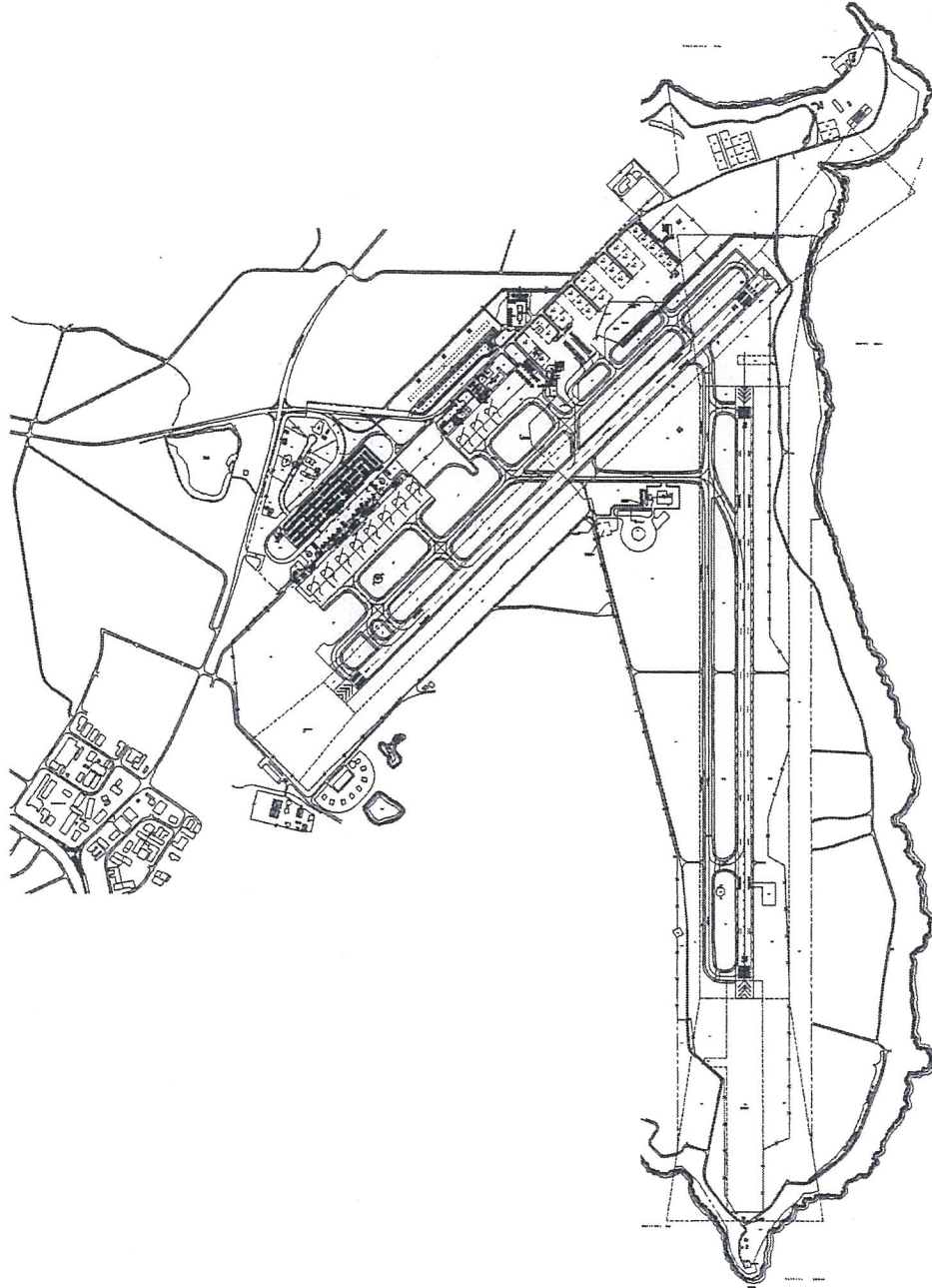

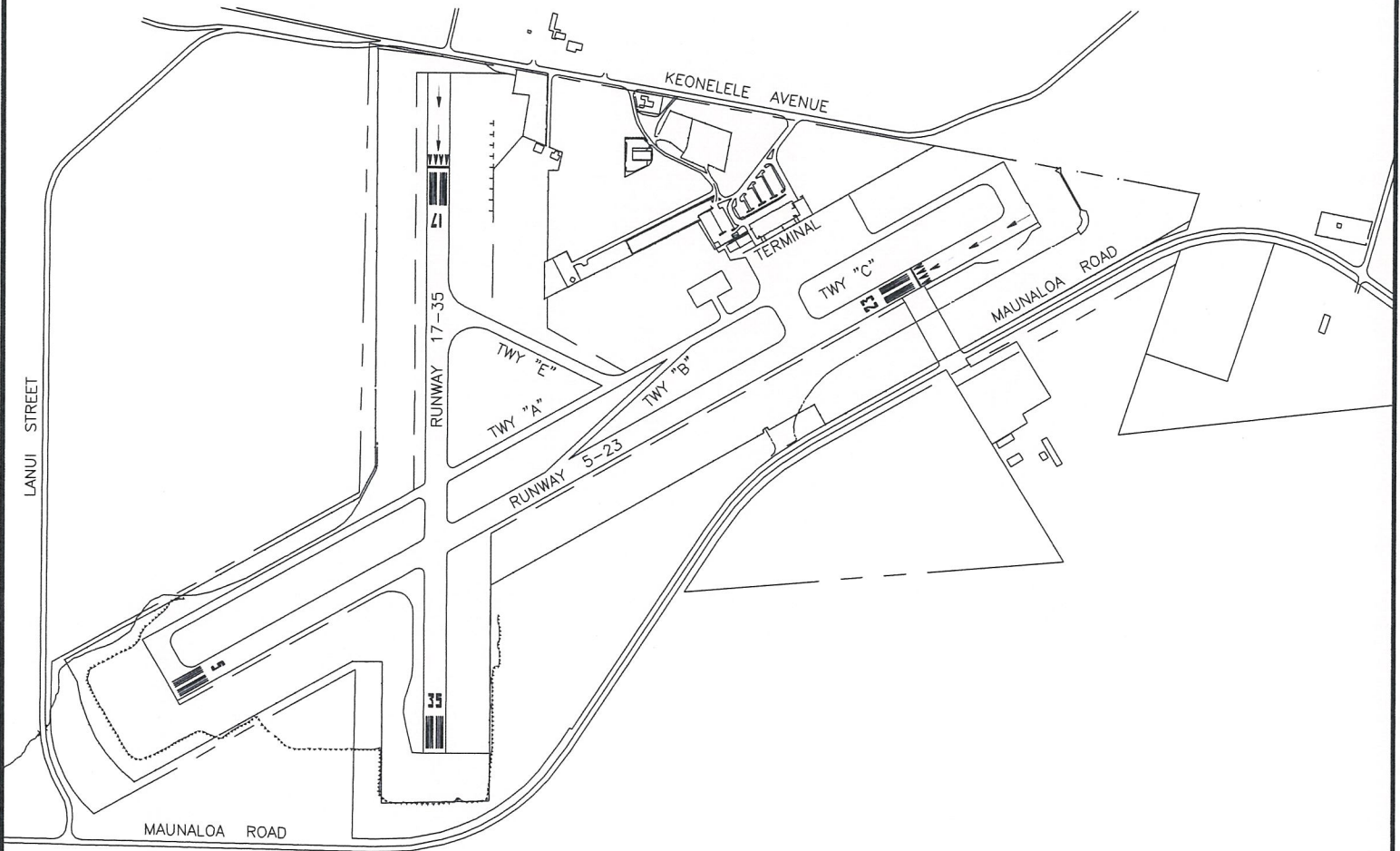
