CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The environmental impacts of the proposed action to the subject land area is covered by the Honolulu International Airport, Airport Modernization Program Environmental Assessment (EA), State Project No. AO1030-13. The EA is a joint State and Federal document dated January 2013, and published in the February 8, 2013 issue of the OEQC

Bulletin. Accordingly, the actions have been determined to have little or no impact upon the environment.

REMARKS:

In accordance with Section 171-55, HRS, relating to <u>Permits</u>, the DOTA proposes to issue a permit to NAN for the use of the space for a construction staging area for equipment and materials, at no charge, as specifically stated under Contract No. 67013, State Project No. AO1114-18, Replacement of Parking Structure Pedestrian Bridges, Section 1.08, <u>Provisions for Field Office/Storage Space</u>: "Pending the availability of space on airport property, the State will issue a permit to the Contractor for the use of the space, at no charge, to be used specifically for a field office and/or storage of materials and equipment...."

RECOMMENDATION:

That the Board authorize the Department of Transportation to issue a month-to-month revocable permit to NAN, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.
