**LEGAL REFERENCE:**

(HRS), as amended.

**APPLICANT:**

Hawaii Stevedores, Inc. (Applicant) is a domestic corporation whose mailing address is  
1601 Sand Island Parkway, Honolulu, Hawaii 96819.

**CHARACTER OF USE:**

Office trailer to support their stevedoring and marine terminal business in Kahului  
Harbor, Maui.

**LOCATION:**

Portion of governmental lands at Pier 1, Kahului Harbor, Maui, Tax Map Key  
No. (2) 3-7-010:006 (P), Governor's Executive Order No. 2986, as shown on the attached  
map labeled Exhibit A.

Determined by appraisal as of March 20, 2019, for Revocable Permits in Kahului Harbor.

**COMMENCEMENT DATE:**

**TRUST LAND STATUS:**

Subsection 5(a) of the Hawaii Admission Act (non-ceded lands).

**CURRENT USE STATUS:**

The Applicant currently has an existing month-to-month permit that occupies a portion of the warehouse at Pier 1, Kahului Harbor, Maui, for an office trailer. The Department of Transportation, Harbors Division (DOT Harbors), has been reviewing all month-to-month permits to ensure compliance with and applicability to Sections 171-17 and 171-55, HRS. The DOT Harbors is updating the Applicant's permit with current appraised rates and updated permit terms (as applicable).

**LAND TITLE STATUS:**

Acquired by the DOT Harbors, through eminent domain proceedings by issuance of Governor's Executive Order No. 2986.

**CHAPTER 343 - ENVIRONMENTAL ASSESSMENT:**

This action is exempt from Office of Environmental Quality Control (OEQC) requirements pursuant to Sub-Chapter 11-200.1, Hawaii Administrative Rules, that exempts the following:

“Exemption Class 1: Operations, repairs or maintenance of existing structures, facilities, equipment or topographical features, involving minor expansion or minor change of use beyond that previously existing.”

The DOT Harbors will submit its publication request of this Exemption Notice to the OEQC for publication on the 8<sup>th</sup> of each month.

**REMARKS:**

The Applicant provides stevedoring and marine terminal services in Hawaii. It provides ship and barge lines along with personnel and equipment to handle the processing of marine cargo from those lines. The Applicant has been doing business in Hawaii under its current name since 1984 but has been in business in Hawaii for almost a century.

Currently the Applicant has an existing month-to-month permit for an office trailer to support its stevedoring and marine terminal business. The DOT Harbors has been reviewing all month-to-month permits to ensure compliance with and applicability to Sections 171-17 and 171-55, HRS.

The existing month-to-month permit was issued on May 26, 2014, and rent is currently \$1,732.50 per month. This Submittal will update and renew the month-to-month permit which is compliant with Chapter 171, HRS.

**RECOMMENDATION:**


