Authorizing the Department of Transportation (DOT) to sign as Grantee to a Grant of Non-Exclusive Easement for traffic signal purposes onto land owned by Willow Plaza, L.L.C. (Willow Plaza) at Puna, Island of Hawaii, Hawaii, Tax Map Key (TMK): (3) 1-5-007:069.

REQUEST:

Authorization for DOT to sign as Grantee to a Grant of Non-Exclusive Easement for traffic signal and related equipment purposes on land owned by Willow Plaza.

LEGAL REFERENCE:

Sections 107-10, 171-30 and Chapter 264, Hawaii Revised Statutes (HRS), as amended.

LOCATION:

The area is located on the Island of Hawaii.

AREA:

TMK: (3) 1-5-007:069. Easement area is approximately 130.68 square feet.

ZONING:

TMK: (3) 1-5-007:069 (Hawaii) is zoned as "Commercial".

LAND TITLE STATUS:

Ceded, Department of Hawaiian Home Lands 30% entitlement lands pursuant to the Hawaii State Constitution:

CURRENT USE STATUS:

The parcel is currently developed as the "Puna Kai Shopping Center". The traffic signal and controller box have been installed within the easement area of approximately 0.003 acre or 130.68 square feet.

COMMENCEMENT DATE:

Upon receipt of approvals from the Board of Land and Natural Resources, approval of the Grant of Non-Exclusive Easement by our Department of the Attorney General, and full-execution of the Grant of Non-Exclusive Easement.

COMPENSATION:

The easement is being given to DOT gratis. The traffic improvements and easement were necessitated by Willow Plaza's proposed development; therefore, Willow Plaza was required to bear all costs for the project and to waive any fair market requirements for DOT.

LIENS AND/OR ENCUMBRANCES:

Not applicable.

CHAPTER 343 – ENVIRONMENTAL ASSESSMENT:

Pursuant to Section 11-200-8, Hawaii Administrative Rules, the use by Willow Plaza is exempt from the preparation of an Environmental Assessment based on the attached Comprehensive Exemption List for the State Department of Transportation dated November 15, 2000. More specifically, Exemption Class 6 for "Installation of traffic signals, pavement marks, and stripping for traffic safety and control".

REMARKS:

Willow Plaza proposed to change the use of their land from a commercial baseyard, to a shopping center. To address the increase in traffic, Willow Plaza was required to install traffic safety improvements which included additional traffic signals. A Grant of Non-Exclusive Easement is required to allow placement of a traffic signal and related equipment onto Willow Plaza's property.

Since the traffic improvements were necessitated by Willow Plaza's development, the improvements were done at Willow Plaza's expense. No federal or state funds were used for the improvements.

DOT will not be charged for the easement, nor will DOT be required to compensate Willow Plaza as the improvements were specifically for Willow Plaza's development and was not part of a DOT project.

The traffic signal and related equipment will be maintained by DOT.

As of September 1, 2018, the Department of the Attorney General has mandated DOT to obtain Board approval for all acquisitions in accordance with HRS 171-30.

RECOMMENDATION:

Authorize DOT to sign a Grant of Non-Exclusive Easement for placement and maintenance of a traffic signal and related equipment on Willow Plaza's property at TMK (3) 1-5-007:069.
