CHAPTER 343, HRS - ENVIRONMENTAL ASSESSMENT:

The State of Hawaii, Department of Transportation, Airports (DOTA), has determined that the environmental impacts for the subject land use is covered by the Kahului Airport Development Plan Environmental Assessment (EA) and Negative Declaration, dated April 1989. Accordingly, all relevant mitigation from the EA and best management practices will be implemented to address the minimum impacts of this action.

REMARKS:

In accordance with Section 171-55, HRS, relating to <u>Permits</u>, the department of Transportation (DOT) proposes to issue a month-to-month revocable permit to SpeediShuttle Tours & Transportation, LLC, for the Taxi Management Concession at Kahului Airport.

The DOT is in the process of assessing the ongoing and future feasibility of the Taxi Management Concession. Therefore, the DOT requests the issuance of a revocable permit to SpeediShuttle Tours and Transportation, LLC, to operate the service until a comprehensive assessment of the Concession can be completed.

RECOMMENDATION:

That the Board authorize the DOT to issue a month-to-month revocable permit to SpeediShuttle Tours and Transportation, LLC, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.
