ISSUANCE OF REVOCABLE PERMIT TO OPERATE THE ON-DEMAND AIRPORT-BASED SHUTTLE BUS CONCESSION SPEEDISHUTTLE, LLC KAHULUI AIRPORT

PURPOSE:

To issue a Revocable Permit to operate the On-Demand Airport-Based Shuttle Bus Concession at the Kahului Airport on the Island of Maui.

CHAPTER 343, HRS – ENVIRONMENTAL ASSESSMENT:

The subject area is confined to an existing office space within the Kahului Airport terminal baggage claim area constructed in the 1990s. No construction improvements are proposed, therefore no environmental impacts are anticipated.

REMARKS:

In accordance with Section 171-55, HRS, relating to <u>Permits</u>, the DOT proposes to issue a month-to-month revocable permit to SpeediShuttle, LLC, for the On-Demand Airport-Based Shuttle Bus Concession at the Kahului Airport.

The DOT is in the process of assessing the ongoing and future feasibility of the On-Demand Airport-Based Shuttle Bus Concession. Therefore, the DOT requests the issuance of a revocable permit to SpeediShuttle, LLC, to temporarily operate the service until a comprehensive assessment of the Concession can be completed.

RECOMMENDATION:

That the Board authorize the DOT to issue month-to-month revocable permit to SpeediShuttle, LLC, subject to: (1) terms and conditions herein outlined, which are by reference incorporated herein; and (2) such additional terms and conditions as may be prescribed by the Director of Transportation to best serve the interests of the State.
