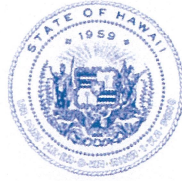

REQUEST:

RECOMMENDATION:



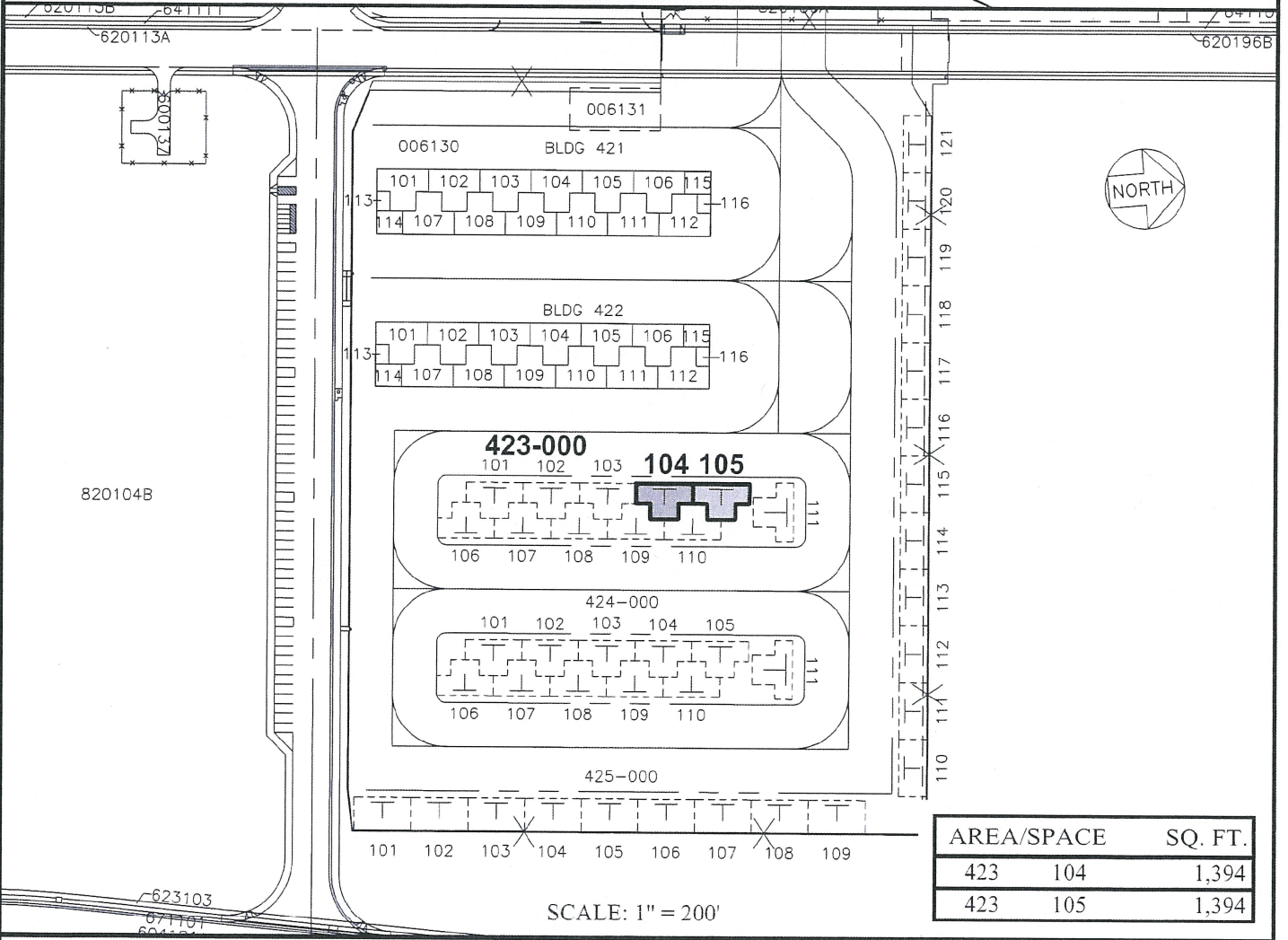
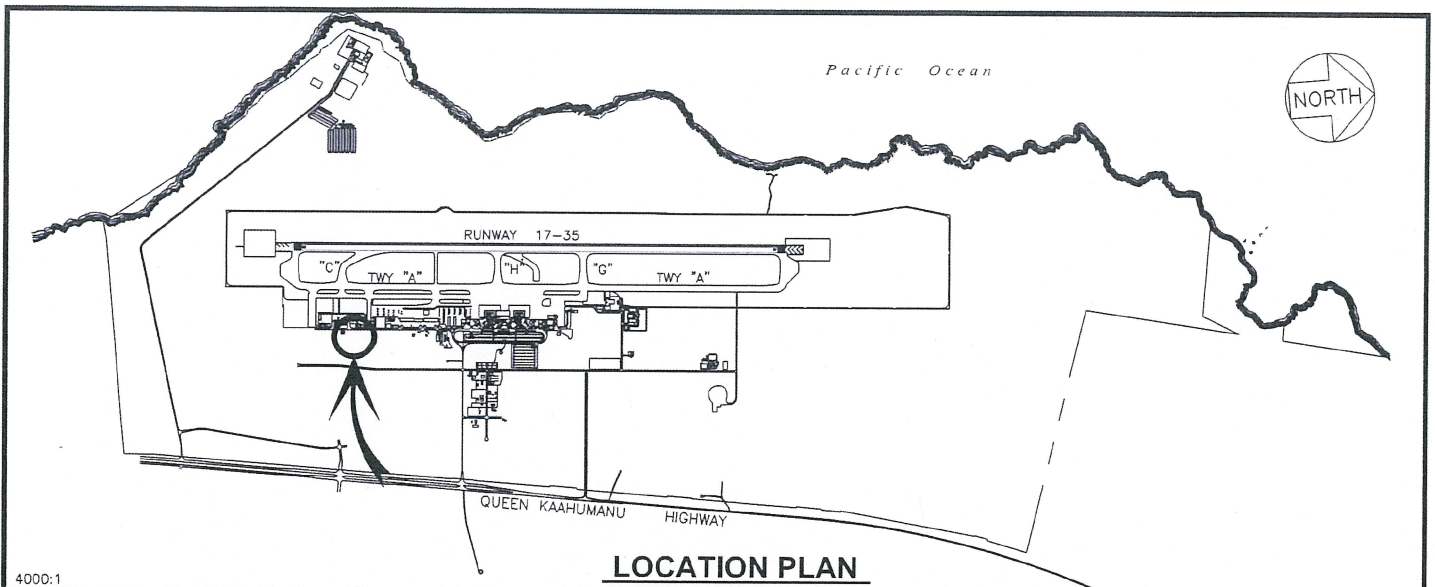
